




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking






Fig. 8.7 IDR - VDS




Fig. 8.9 V_{th} - T_a




Fig. 8.11 P_D - T_c (Guaranteed Maximum)




Fig. 8.8 Capacitance - V_{DS}





Fig. 8.10 Dynamic Input/Output Characteristics


