

- Note 1: If a reverse bias is applied between gate and source, this device enters  $V_{(BR)DSX}$  mode. Note that the drain-source breakdown voltage is lowered in this mode.
- Note 2: Let  $V_{th}$  be the voltage applied between gate and source that causes the drain current ( $I_D$ ) to below (-1 mA for this device). Then, for normal switching operation,  $V_{GS(ON)}$  must be higher than  $V_{th}$ , and  $V_{GS(OFF)}$  must be lower than  $V_{th}$ . This relationship can be expressed as:  $V_{GS(OFF)} < V_{th} < V_{GS(ON)}$ .






Fig. 5.3.1 Switching Time Test Circuit







Fig. 8.1 I<sub>D</sub> - V<sub>DS</sub>






Fig. 8.3 R<sub>DS(ON)</sub> - V<sub>GS</sub>




Fig. 8.4 R<sub>DS(ON)</sub> - V<sub>GS</sub>




Fig. 8.5 R<sub>DS(ON)</sub> - I<sub>D</sub>





Fig. 8.6 R<sub>DS(ON)</sub> - T<sub>a</sub>









Fig. 8.8 |Y<sub>fs</sub>| - I<sub>D</sub>







Fig. 8.9 IDR - VDS

Fig. 8.10 C - V<sub>DS</sub>






Fig. 8.12 Dynamic Input/Output Characteristics







Fig. 8.13 P<sub>D</sub> - T<sub>a</sub>
