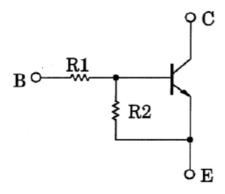

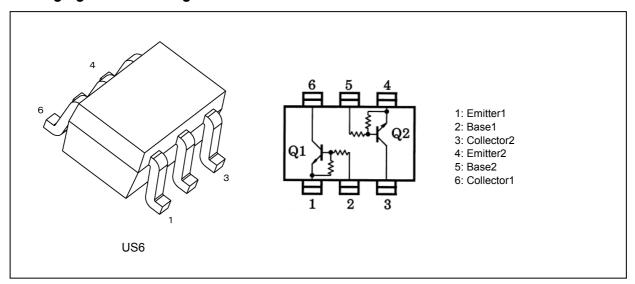

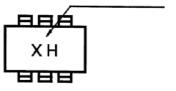


Fig. 9.1 Marking RN1907

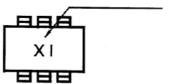
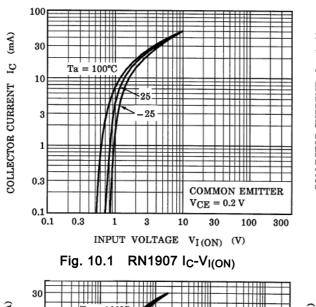
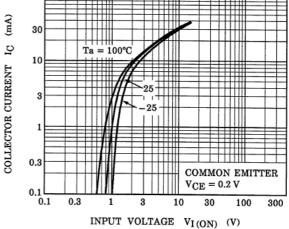


Fig. 9.2 Marking RN1908

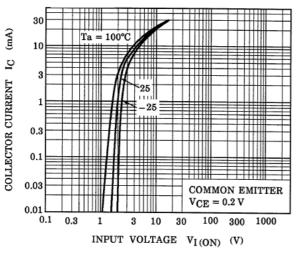

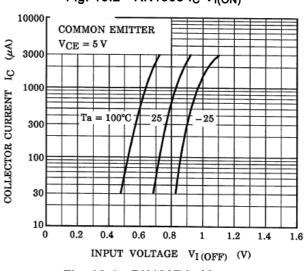
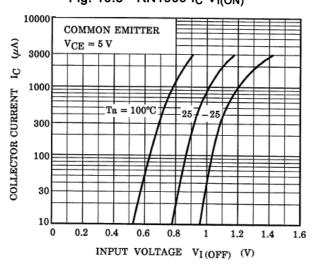


Fig. 10.3 RN1909 I<sub>C</sub>-V<sub>I(ON)</sub>

Fig. 10.4 RN1907 I<sub>C</sub>-V<sub>I(OFF)</sub>



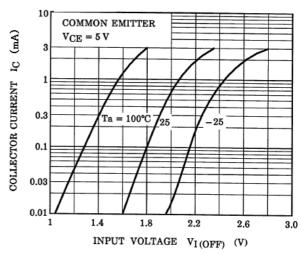
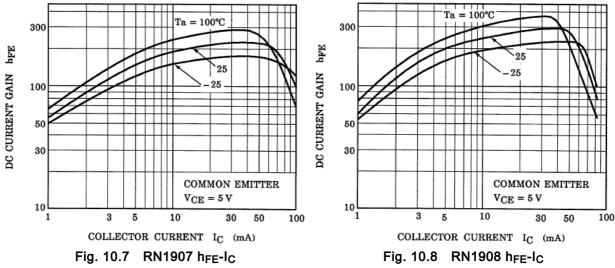


Fig. 10.5 RN1908 I<sub>C</sub>-V<sub>I(OFF)</sub>

Fig. 10.6 RN1909 I<sub>C</sub>-V<sub>I(OFF)</sub>





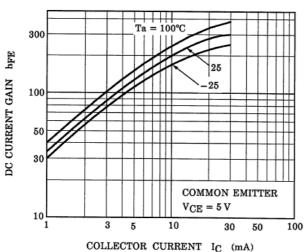


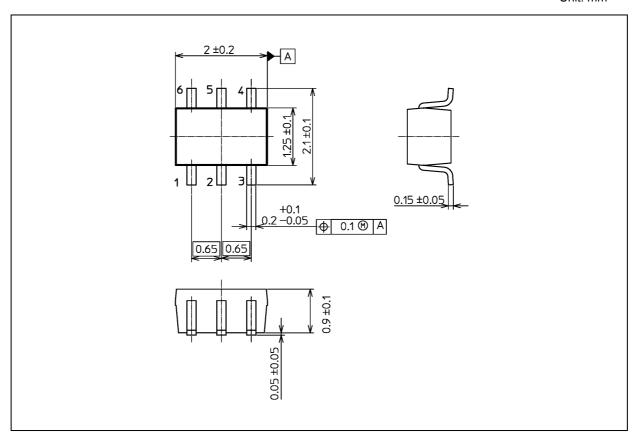
Fig. 10.9 RN1909 h<sub>FE</sub>-I<sub>C</sub>
