




Fig. 6.3.1 Switching Time Test Circuit






Fig. 8.1 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.2 I<sub>D</sub> - V<sub>GS</sub>




Fig. 8.3 R<sub>DS(ON)</sub> - I<sub>D</sub>




Fig. 8.4 R<sub>DS(ON)</sub> - V<sub>GS</sub>




Fig. 8.5 R<sub>DS(ON)</sub> - T<sub>a</sub>







Fig. 8.6 V<sub>th</sub> - T<sub>a</sub>













Fig. 8.9 Dynamic Input Characteristics

Fig. 8.10 t - I<sub>D</sub>




