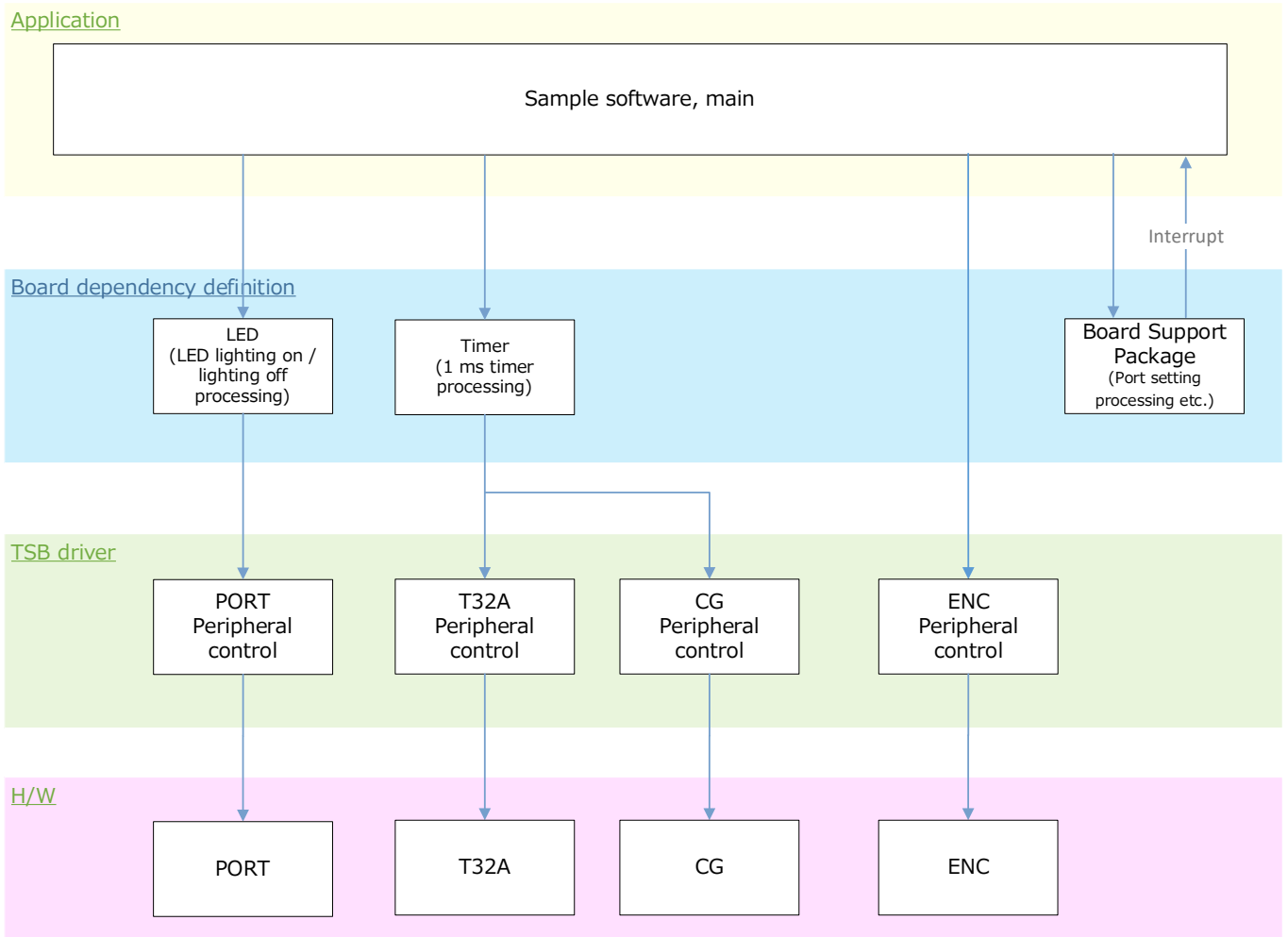

## 6. Sample Program:A\_ENC32

This sample software uses the rotation detection function of A\_ENC to change the blinking LED according to the rotation direction. The blinking interval is changed according to the rotation speed. The rotary encoder is detected in the encoder mode.

### 6.1. Outlines of Operation

In case of clockwise rotation, BSP\_LED\_1 blinks.  
 In case of counterclockwise rotation, BSP\_LED\_2 blinks.  
 Change the flashing interval according to the number of rotations (X).  
 The blink interval is set in 6.4 Configuration.

### 6.2. Function to Use

The functions to use are as follows:  
 For the Port assignment of each BSP channel, refer to the MCU user guide.
