## Switching Time Test Circuit


$V_{\text {th }}$ can be expressed as the voltage between the gate and source when the low operating current value is $\mathrm{ID}=$ -0.1 mA for this product. For normal switching operation, VGS (on) requires a higher voltage than Vth and VGS (off) requires a lower voltage than $\mathrm{V}_{\mathrm{th}}$. (The relationship can be established as follows: $\mathrm{V}_{\mathrm{GS}}$ (off) $<\mathrm{V}_{\text {th }}<\mathrm{V}_{\mathrm{GS}}$ (on).)
