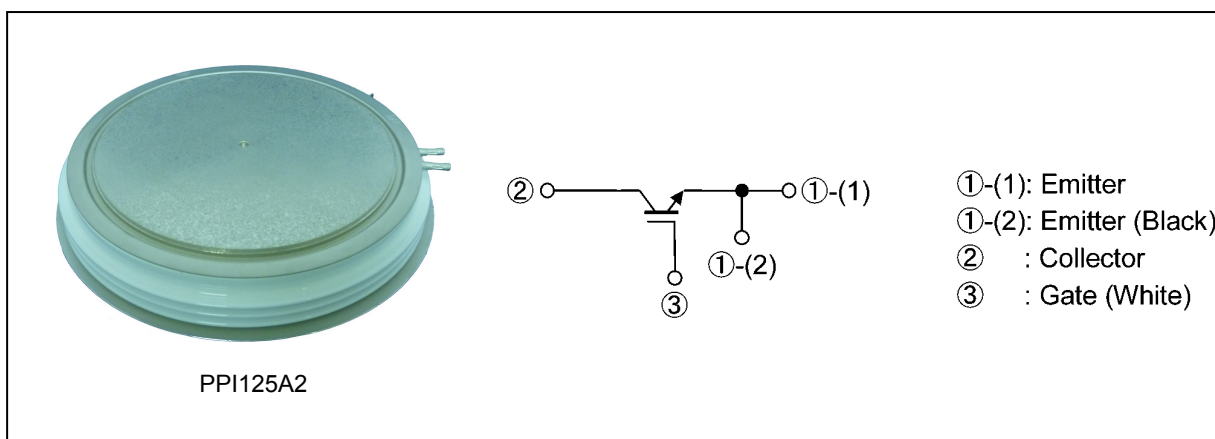

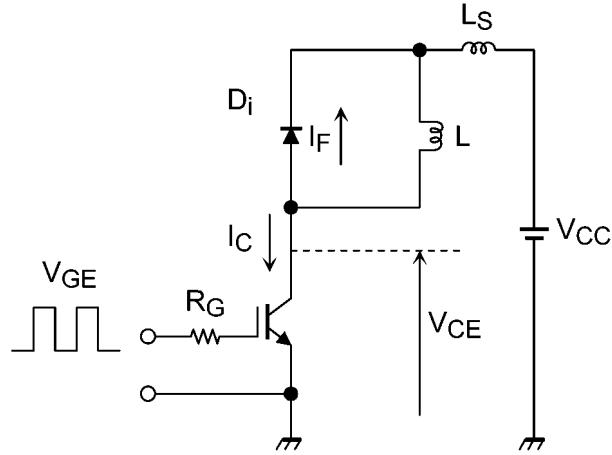


Fig. 6.1 Test Circuit

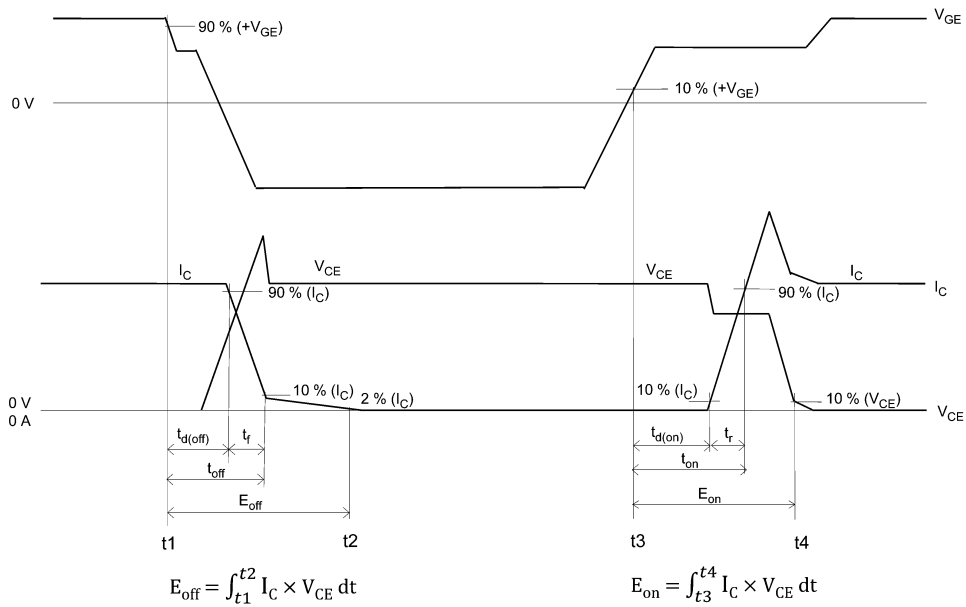


Fig. 6.2 Timing Chart

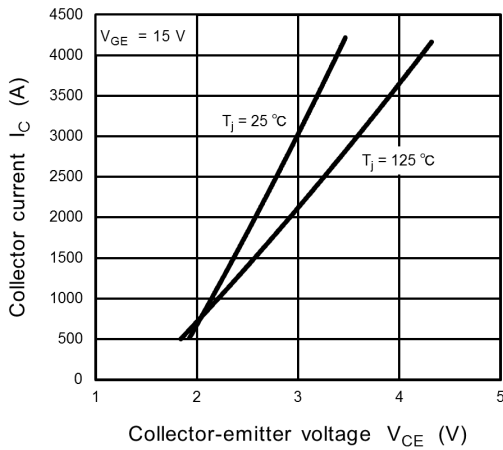


Fig. 7.1 $I_C - V_{CE}$

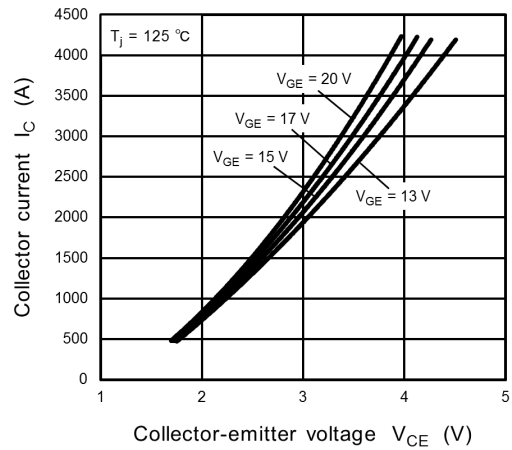


Fig. 7.2 $I_C - V_{CE}$

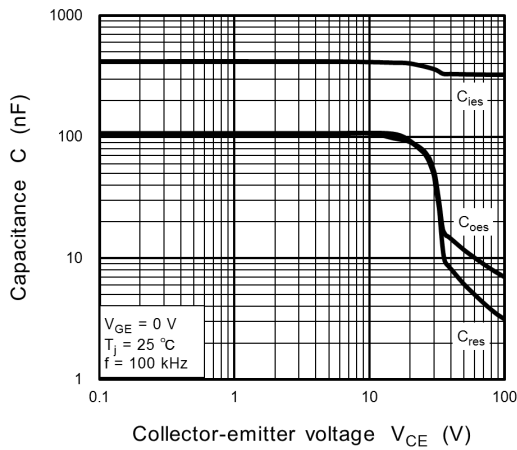


Fig. 7.3 $C_{ies}, C_{oes}, C_{res} - V_{CE}$

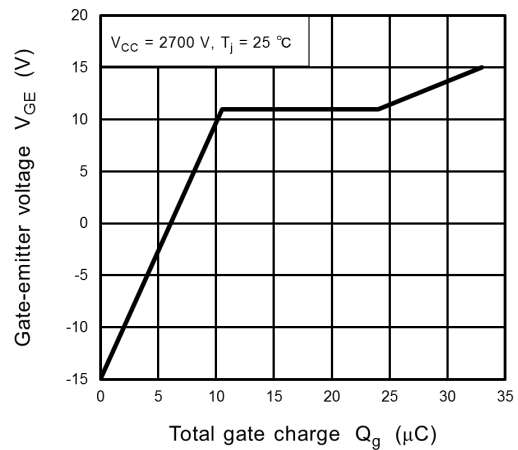


Fig. 7.4 $V_{GE} - Q_g$

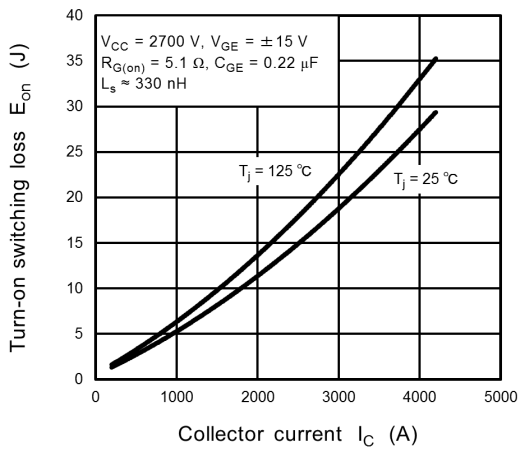


Fig. 7.5 $E_{on} - I_C$

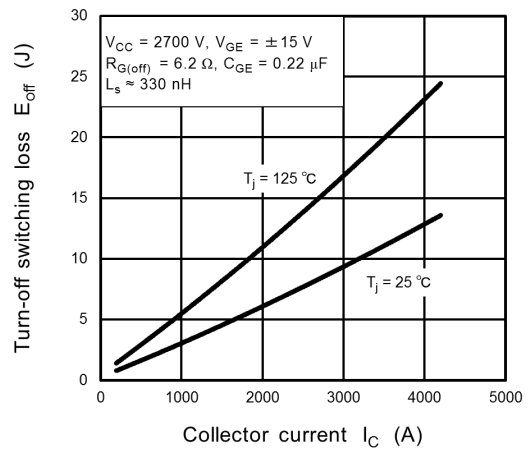


Fig. 7.6 $E_{off} - I_C$

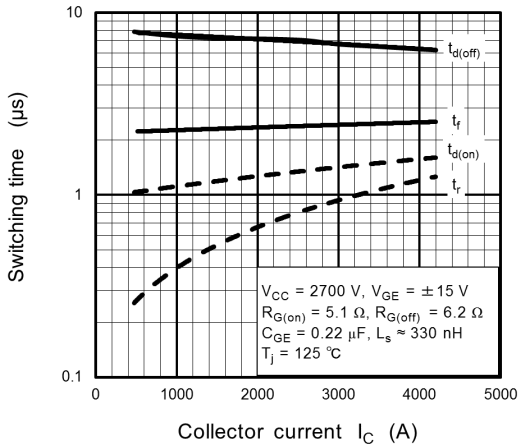


Fig. 7.7 $t_{d(off)}, t_r, t_{d(on)}, t_r - I_C$

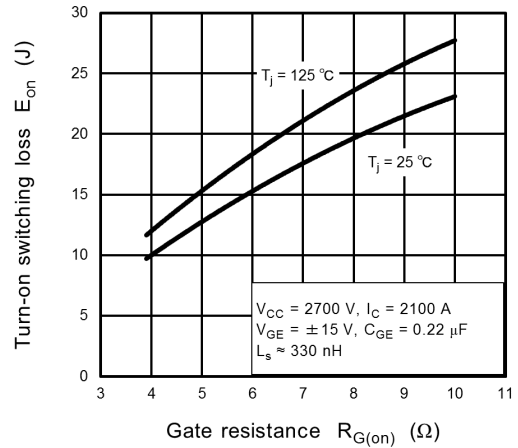


Fig. 7.8 $E_{on} - R_{G(on)}$

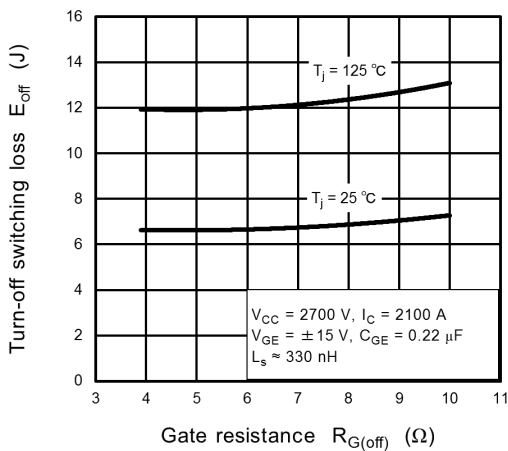


Fig. 7.9 $E_{off} - R_{G(off)}$

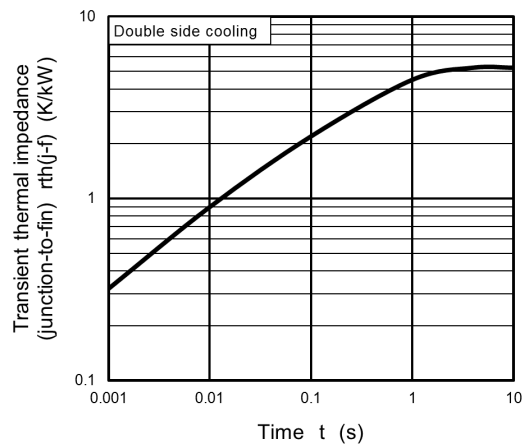


Fig. 7.10 $r_{th(j-f)} - t$

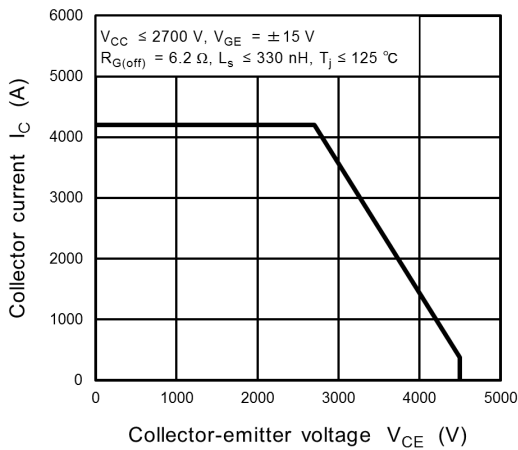
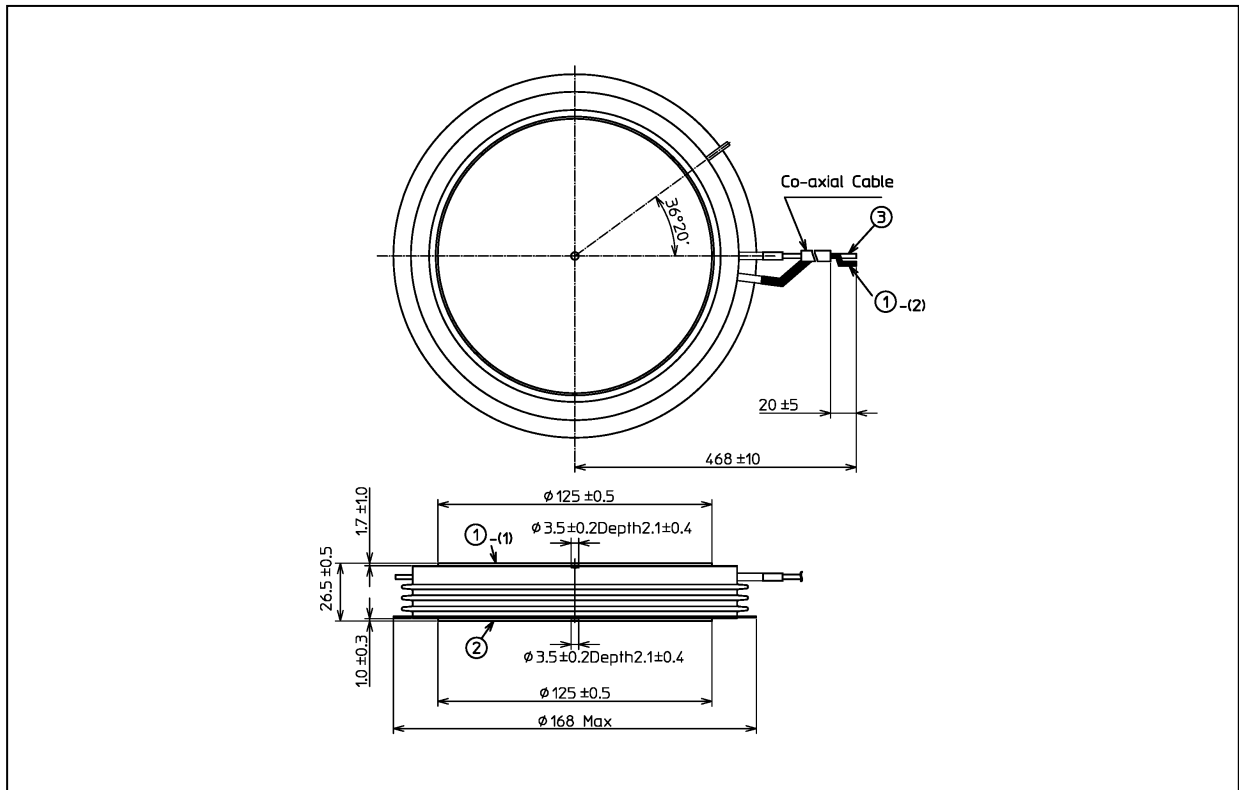


Fig. 7.11 RBSOA
