




Fig. 4.1 Definitions of Electrical Characteristics




Fig. 6.1 Marking






Fig. 7.1 Land Pattern Dimensions (Unit: mm)





9. Clamp Voltage V_C - Peak Pulse Current (I_{PP}) (Note)





11. ESD Clamp Waveform (Note)


