

6. Sample Program: Flash_Data

This sample software programs data to a special region of Flash memory or erases it using Flash memory function.

6.1. Outlines of Operation

A start-up message is displayed on the terminal emulator at start-up.

When a corresponding BSP_PSW_3 is pushed down, an area erase is done (0x30000000 to 0x30007FFF). And "Area4 Erased" message is displayed on the terminal emulator.

Then, data 0x00 to 0xFF are programed to the regions of Page0 and Page1 (0x30000000 to 0x300000FF and 0x30000100 to 0x300001FF, respectively). And "Rewriting" message is displayed.

Next, the Page0 region (0x30000000 to 0x300000FF) is erased, and "Page0 Erasing" message is displayed.

After completion of the erase of the Page0 region, the Block0 region (0x30000000 to 0x30000FFF) is erased, and "Block0 Erasing" message is displayed.

At last, "Finished" message is displayed.

If the BSP PSW 3 is pushed down again, the same process is executed.

6.2. Function to Use

The functions to use are as follows.

For the Port assignment of each channel, refer to the MCU user manual.
