

6. Sample Program: I2S_MASTER

This sample software transmits voice binary data using I2S function.

6.1. Outlines of Operation

- 1-kHz sine wave voice binary data is calculated. The calculated data is stored to 48 data tables of the "int" type and outputs in the I2S Master mode.
- The voice mute turns ON and OFF alternately every BSP_PSW_1 push-down. The initial setting after Reset is mute-OFF.
