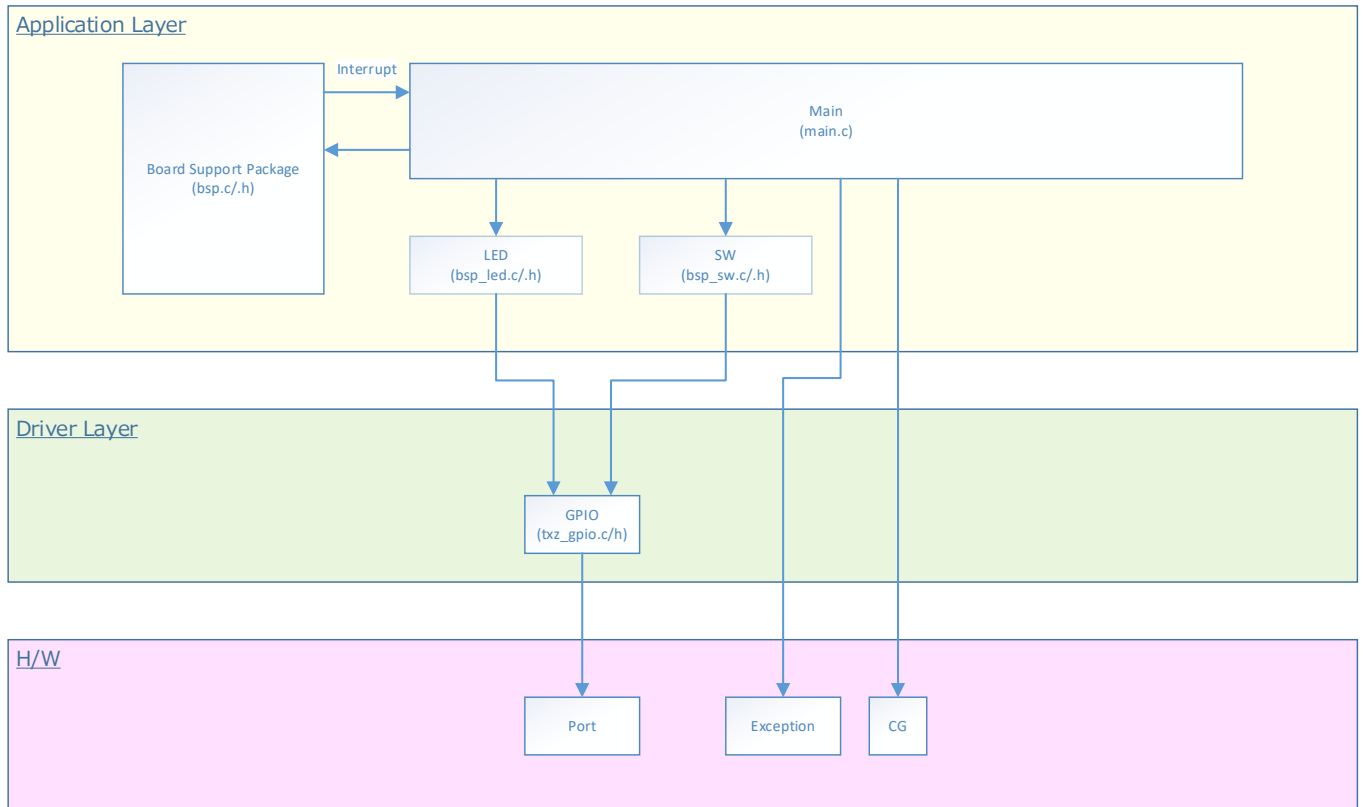

6. Sample Program: PORT_LED

This sample software detects the push-down of a push switch, and turns on and off the corresponding LED's.

6.1. Outlines of Operation

When the BSP_PSW_0 switch is pushed down, the BSP_LED_0 turns on. When the switch is not pushed down, the LED turns off.

When the BSP_PSW_1 switch is pushed down, the BSP_LED_1 turns on. When the switch is not pushed down, the LED turns off.

When the BSP_PSW_2 switch is pushed down, the BSP_LED_2 turns on. When the switch is not pushed down, the LED turns off.

When the BSP_PSW_3 switch is pushed down, the BSP_LED_3 turns on. When the switch is not pushed down, the LED turns off.
