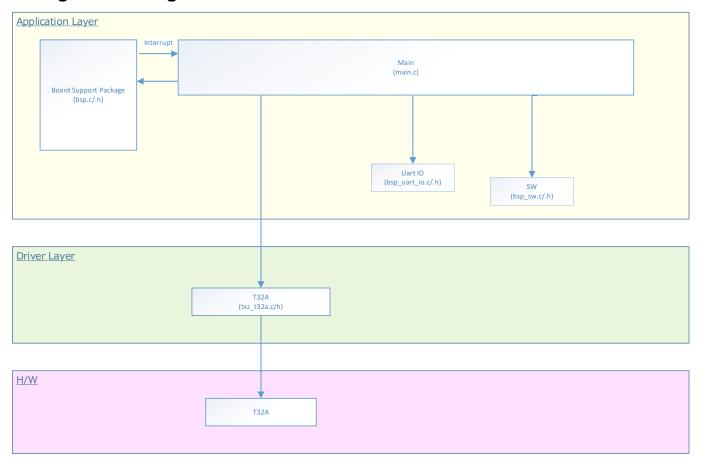

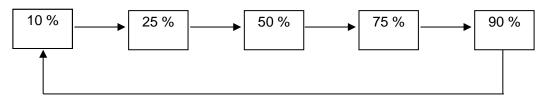
### 6. Sample Program: Timer\_PPG

This sample software changes step by step the duty ratio of the output signal from T32A PPG circuit.

#### 6.1. Outlines of Operation

When BSP\_PSW\_0 is pushed down, the PPG starts to output a signal. When BSP\_PSW\_1 is pushed down, the PPG stops and the duty ratio of the output signal is changed.

If the BSP\_PSW\_0 is pushed down twice continuously, Time error occurs. The BSP\_PSW\_0 should be pushed down to output the PPG signal after the BSP\_PSW\_1 is pushed down to stop the PPG and to change the duty ratio.

The functions to use are as follows.
