

### 6. Sample Program: ETHM\_LoopBack

This sample program sends and receive string "TOSHIBA" by ETHM loop back, and displays data received to the terminal software.

### **6.1. Outlines of Operation**

"command>" is displayed on the terminal emulator, and type "write" if send data.

If "write" command is typed, character string "TOSHIBA" is send, and terminal emulator returns "command>" display. type "read" if receive data.

If "read" command is typed, received data is read, it is displayed on the terminal emulator, and terminal emulator returns "command>" display.

The functions to use are as follows.
