

This sample software measures voltage with ADC. It sends and receives conversion result value with test loop back mode of CAN, and display received data on the terminal emulator.

6.1. Outlines of Operation

Voltage 1ch is measured every five seconds by BSP_ADC_0. Conversion result value sends and receives by test loop back mode of CAN, and display received data on the terminal emulator.
