

### 6. Sample Program: SMIF\_QUAD\_UART

This sample software executes the "write" or "read" command which is input to the terminal software. When the "write" command is input, successively input characters are stored to the SRAM. When the "read" command is input, the data in the SRAM is displayed on the terminal software.

#### 6.1. Outlines of Operation

"command >" is displayed on the terminal software. The command is input according to the format of the following "write" command or "read" command. When the "write" command is executed, the input data is stored to the SRAM (address: 0x0000000). When the "read" command is executed, the data in the SRAM (address: 0x0000000) is read, and is displayed on the terminal software.

And when the "damp" command is input, the data in the SRAM is displayed on the terminal software.

 Command format: "write" command write \_ X X: Any characters (16 characters or less) "read" command read "damp" command damp\_xxxxxx\_yyyy xxxxxx: Start address (Hexadecimal: 0 to FFFFF) yyyy: Display byte count (Hexadecimal: 0 to FFFF) When the start address and the display byte count are omitted, "damp 0 20" is executed.

The functions to use are as follows. For the Port assignment of each channel, refer to the MCU user manual.


