




Fig. 6.1 Test Circuit




Fig. 6.2 Timing Chart




Fig. 7.1 I_F - V_F




Fig. 7.2 E_{rr} - I_F




Fig. 7.3 R_{th(j-f)} - t (Guaranteed value)





Fig. 7.4 RRSOA (Guaranteed value)
