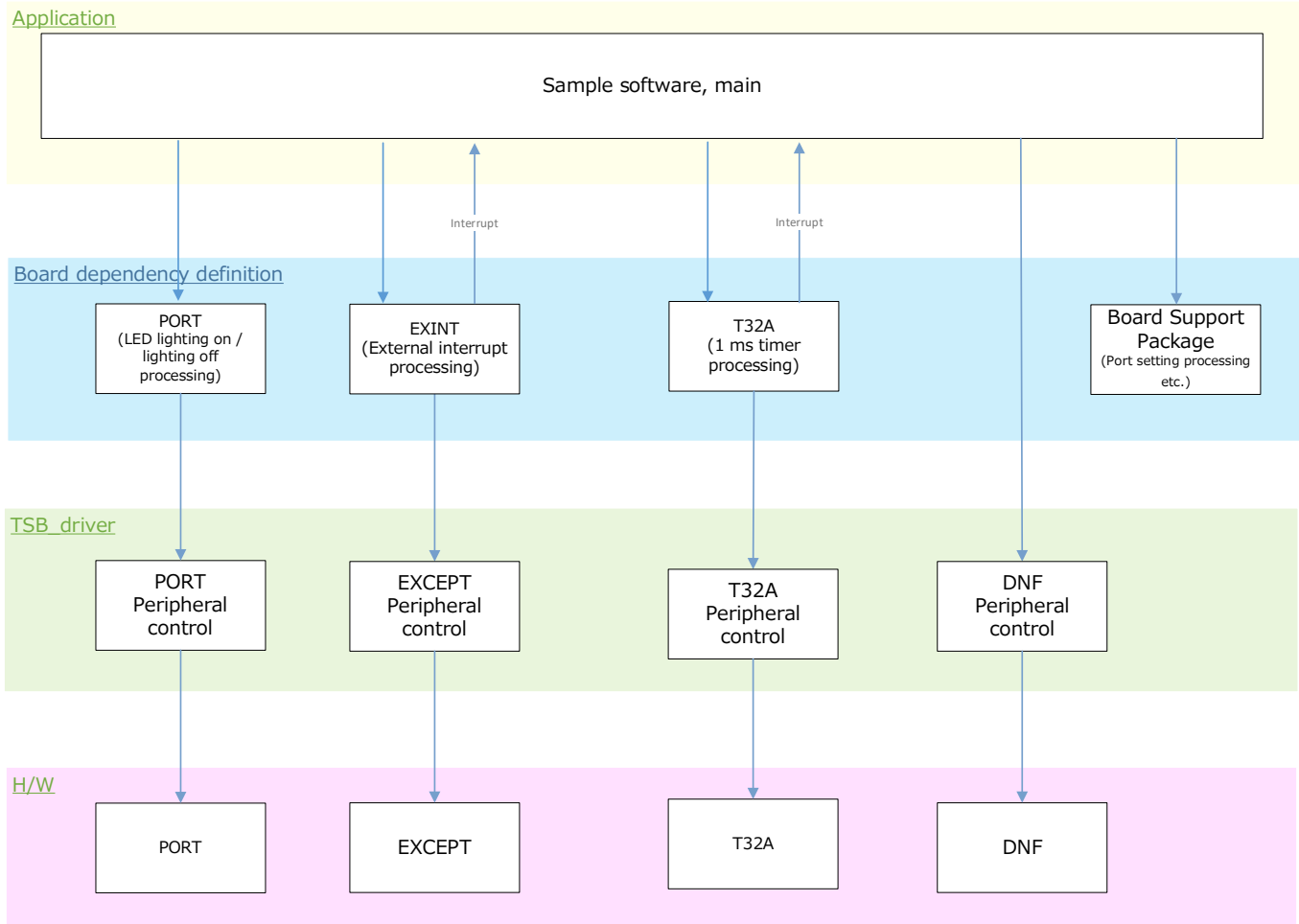

## 6. Sample Program:DNF

This is sample software that displays the external signal interrupt detection by pressing Push-Switch by switching the LED lighting.

### 6.1. Outlines of Operation

BSP\_LED\_1 is controlled when BSP\_PSW\_5 is pressed.

If you press BSP\_PSW\_5 when BSP\_LED\_1 is off, BSP\_LED\_1 will turn on.

If BSP\_PSW\_5 is pressed while BSP\_LED\_1 is on, BSP\_LED\_1 will turn off.

Detects external signal interrupts caused by pressing Push-Switch via DNF.

### 6.2. Function to Use

The functions to use are as follows:

For the Port assignment of each BSP channel, refer to the MCU user guide.

IP	Channel	Objective
PORT (Push-Switch)	(Note1): BSP_PSW_5	(Note1): For event triggers
PORT (LED)	BSP_LED_1	For operation check
T32A	BSP_T32A_TIMER_1	For Interval timer

Note1: For SBK-M471, use BSP\_SSW\_1 instead.

### 6.3. Interrupt to Use

Interrupt	Outlines
(Note1)	External interrupt when PSW_5 is pressed
(Note2)	T32A Timer A Timer counter increment every 1ms for Switch processing

Note1: For SBK-M471, "INT3".

For AdBun-M3HQA, "INT18".

Note2: For SBK-M471 and AdBun-M3HQA, it is "INTT32A00AC".
