

### 6. Sample Program : ADC\_SoftwareTrigger

This is sample software that outputs the conversion data to the terminal emulator using the ADC function.

#### 6.1. Outlines of Operation

The output voltage of BSP\_THERMISTOR\_1 is measured by the ADC, and the temperature-converted value is output to the terminal emulator.

The variable voltage values of BSP\_VR\_1 and BSP\_VR\_2 are measured by ADC and the measurement data is output to the terminal emulator.

The terminal software outputs at 5 second intervals.

6.4. It is possible to change the output interval in the configuration.

#### 6.2. Function to Use

The functions to use are as follows.

For the Port assignment of each channel, refer to the MCU user manual.

ADC	BSP_VR_1	Measure the voltage obtained with variable resistor 1
