

6. Sample Program: RTC

This sample software is clock control software. The LED is turn on / off every time Timer_A elapses.

6.1. Outlines of Operation

The calendar and time are displayed on the terminal software. Set the initial time and switch BSP_LED_1 ON / OFF every time Timer_A elapses. Outputs a log every time Timer_B elapses.

6.2. Function to Use

The functions to use are as follows.

For the Port assignment of each channel, refer to the MCU user manual.

IP	Channel	Objective
PORT(LED)	BSP_LED_1	For operation check
UART	BSP_UART_1	For terminal emulator communication (Outputs log)

6.3. Interrupt to Use

Interrupt	Outlines
INTRTC	RTC interrupt. Get date / time
INTUART0RX	UART ch0 Receive interrupt for terminal emulator
INTUART0TX	UART ch0 Transmission interrupt for terminal emulator
INTUART0ERR	UART ch0 Error interrupt for terminal emulator
