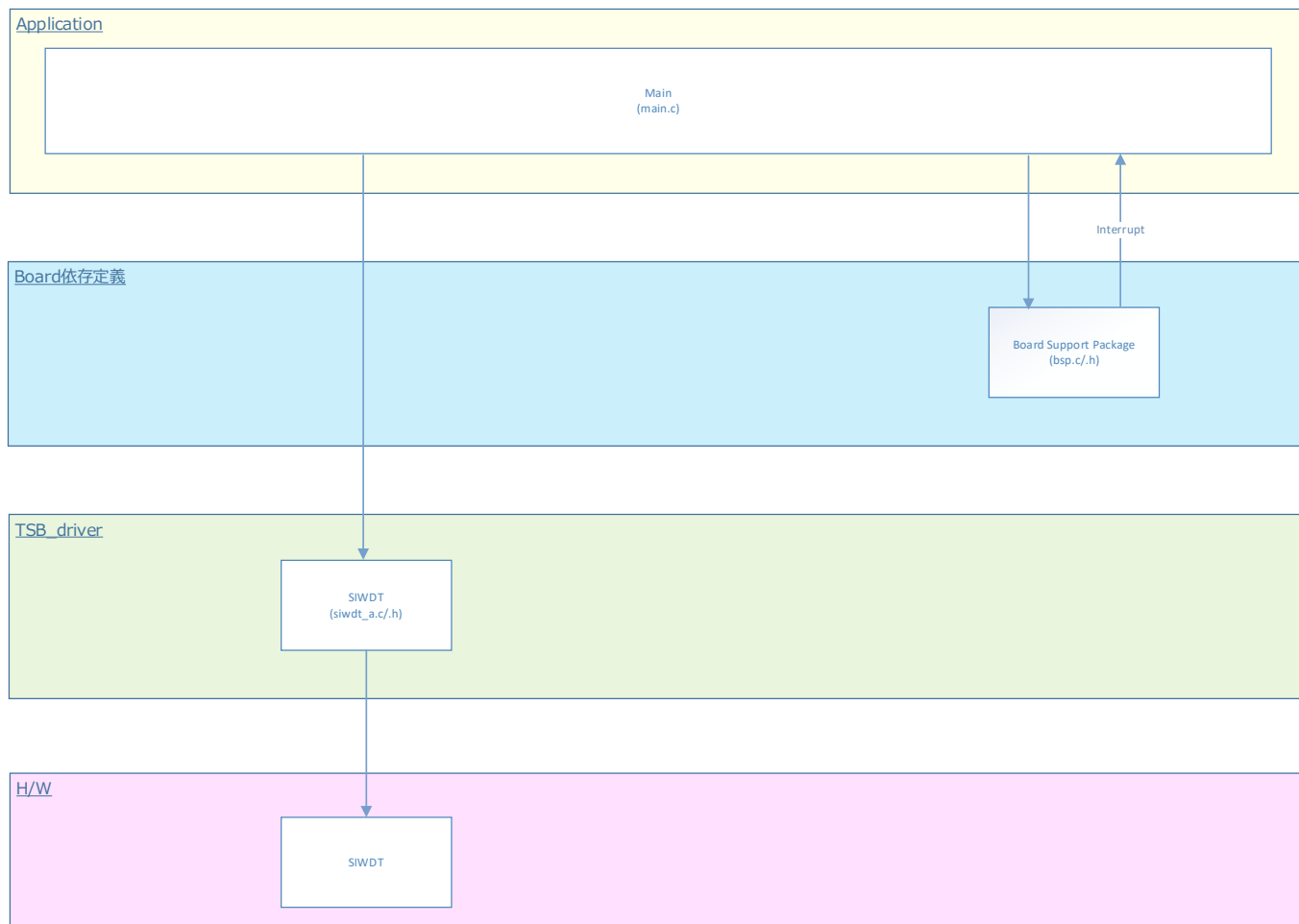

6. Sample Program : SIWDT

This sample software is a watchdog timer software.

6.1. Outlines of Operation

The LED is turn ON / OFF each time Timer_A elapses.

After about 1.1 seconds, the watchdog timer interrupt occurs and the watchdog timer is cleared.

6.2. Function to Use

The functions to use are as follows.

For the Port assignment of each channel, refer to the MCU user manual.
