

### 6. Sample Program: TRM

This is sample software that trims the built-in oscillation (fIHOSC) using the reference clock (low-speed oscillator (fs) or external reference clock (BSP\_T32A\_CAPT\_1)). The compile option toggles the reference clock.

#### 6.1. Outlines of Operation

Pulse B is output from BSP\_T32A\_PPG\_2. After that, set the trimming initial setting value. Error measurement (waveform measurement) is performed until the number of trimmings is reached.

#### 6.2. Function to Use

The functions to use are as follows.

For the Port assignment of each channel, refer to the MCU user manual.

IP	Channel	Objective
T32A	BSP_T32A_CAPT_1	For pulse measurement. Used to measure the external reference clock
132A	BSP_T32A_TRM_fs	For pulse measurement. Used for measuring fs
	BSP_T32A_PPG_2	For pulse output. Used to check the error correction result
UART	BSP_UART_1	For terminal emulator communication (Outputs log)
