




Fig. 5.1 Device Mounted on a Glass-Epoxy
Board (a)




Fig. 5.2 Device Mounted on a Glass-Epoxy Board (b)




Fig. 6.2.1 Switching Time Test Circuit








Fig. 8.7 IDR - VDS




Fig. 8.9 V<sub>th</sub> - T<sub>a</sub> (Note 8)




Fig. 8.11 P<sub>D</sub> - T<sub>a</sub> (Guaranteed Maximum) (Note 8)




Fig. 8.8 Capacitance - V<sub>DS</sub>




Fig. 8.10 Dynamic Input/Output Characteristics




Fig. 8.12 r<sub>th</sub> - t<sub>w</sub> (Guaranteed Maximum)




Fig. 8.13 Safe Operating Area (Guaranteed Maximum)




