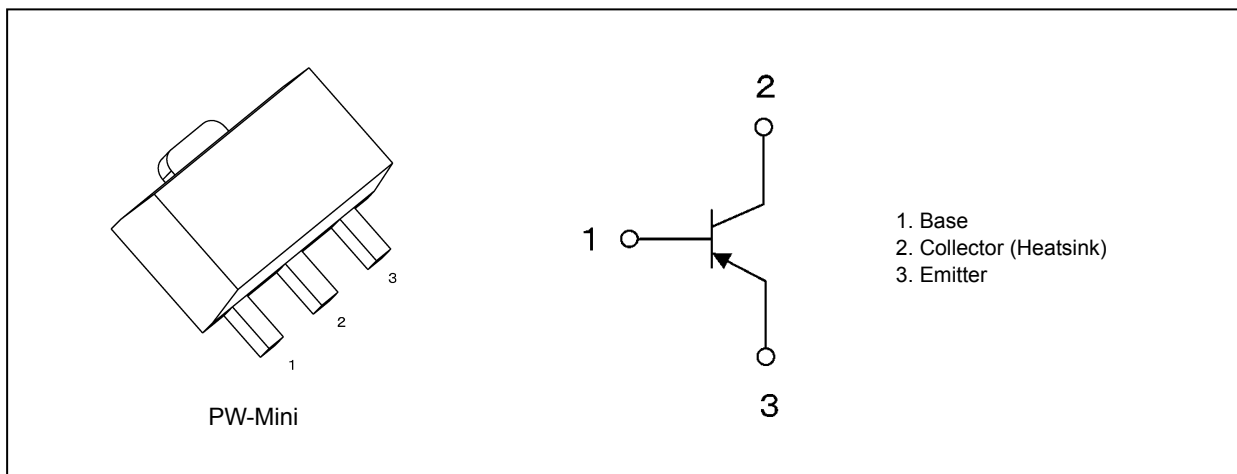

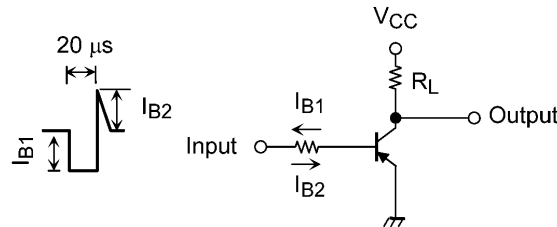

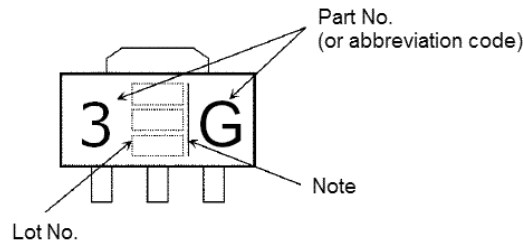


Fig. 6.1 Marking

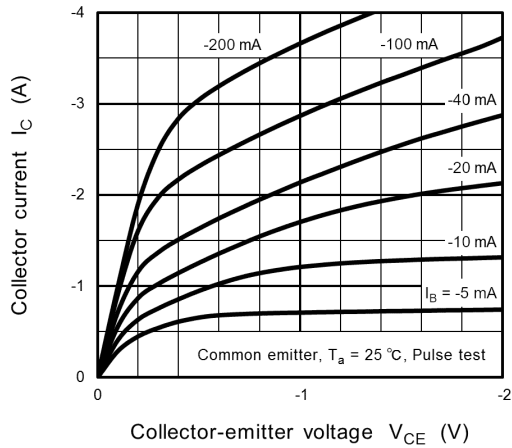


Fig. 7.1 $I_C - V_{CE}$

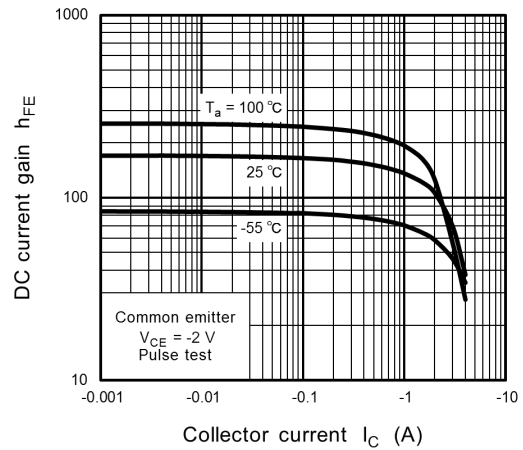


Fig. 7.2 $h_{FE} - I_C$

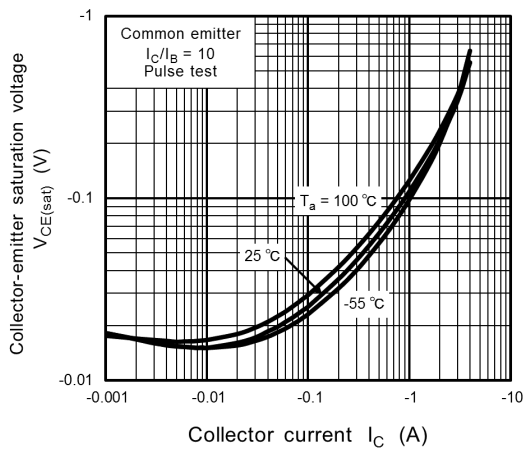


Fig. 7.3 $V_{CE(sat)} - I_C$

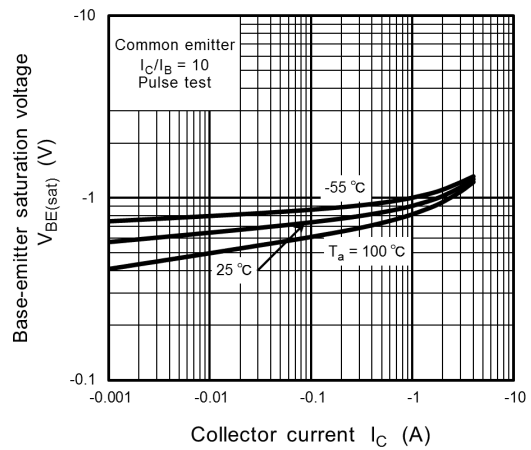


Fig. 7.4 $V_{BE(sat)} - I_C$

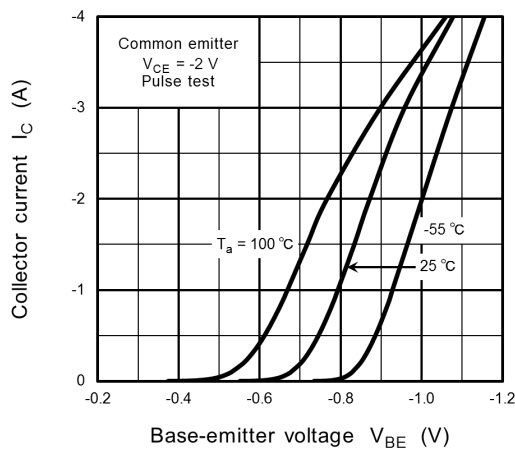


Fig. 7.5 $I_C - V_{BE}$

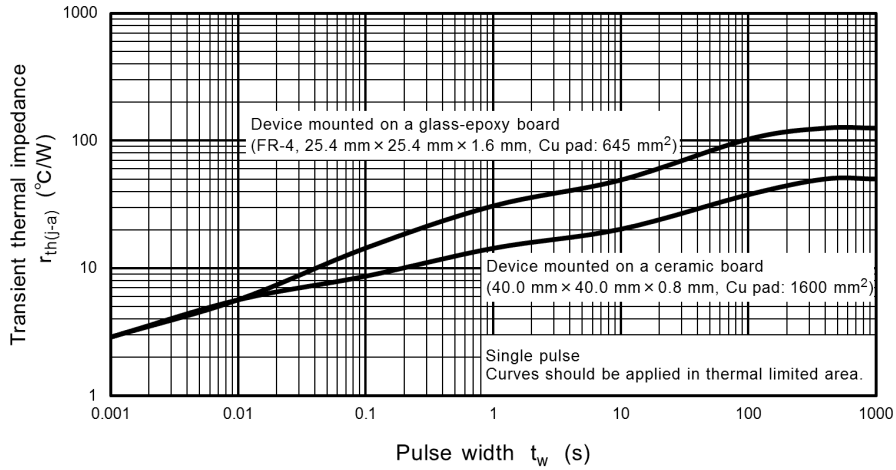


Fig. 7.6 $r_{th} - t_w$
(Guaranteed Maximum)

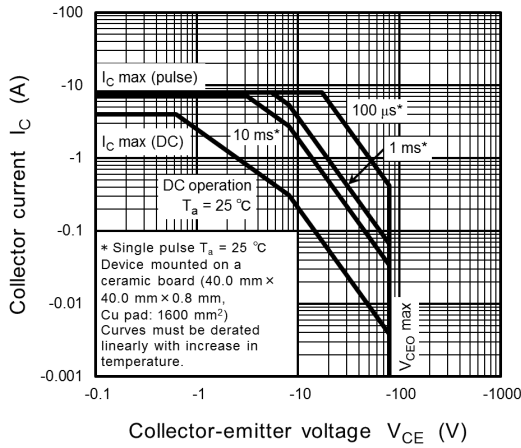
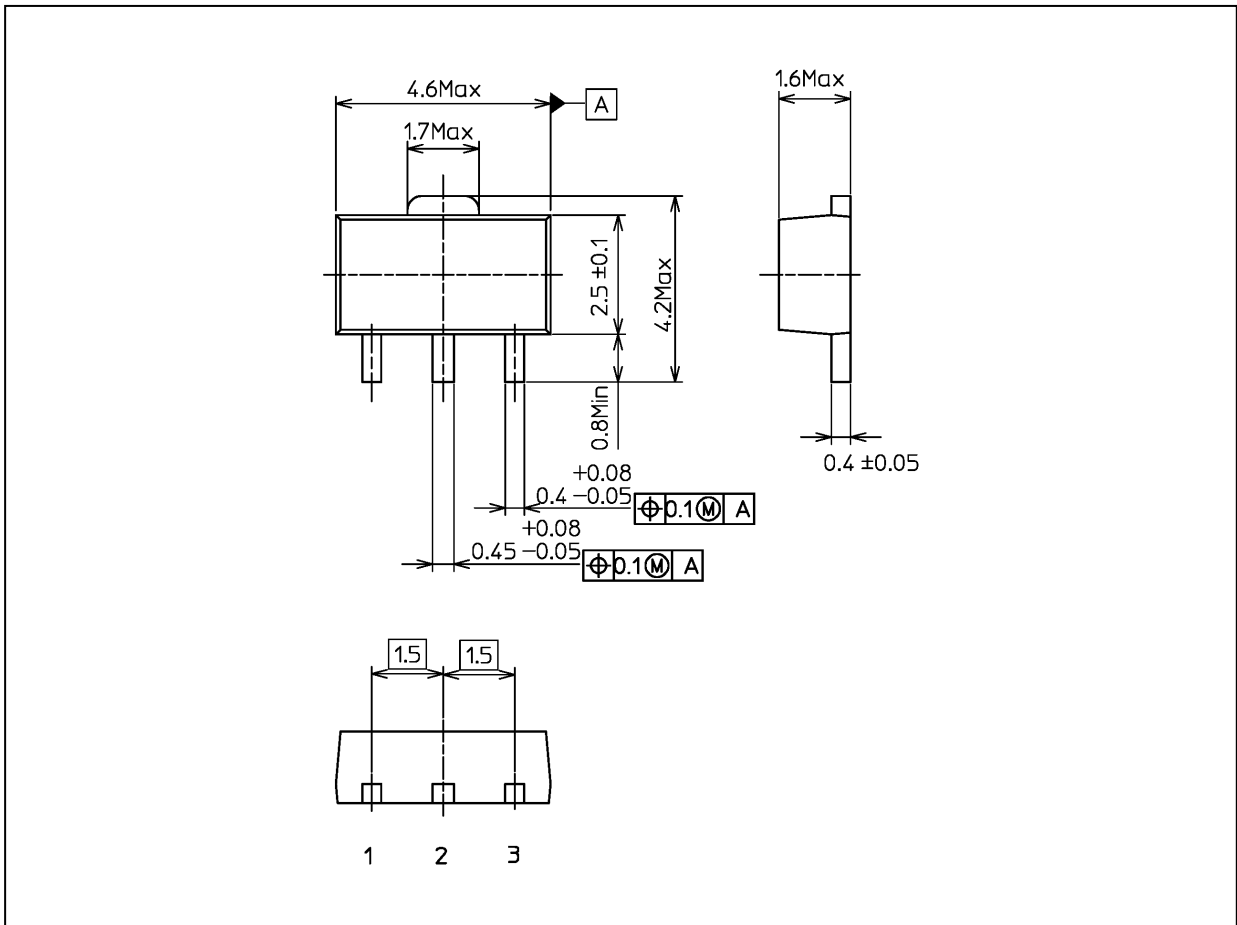


Fig. 7.7 Safe Operating Area
