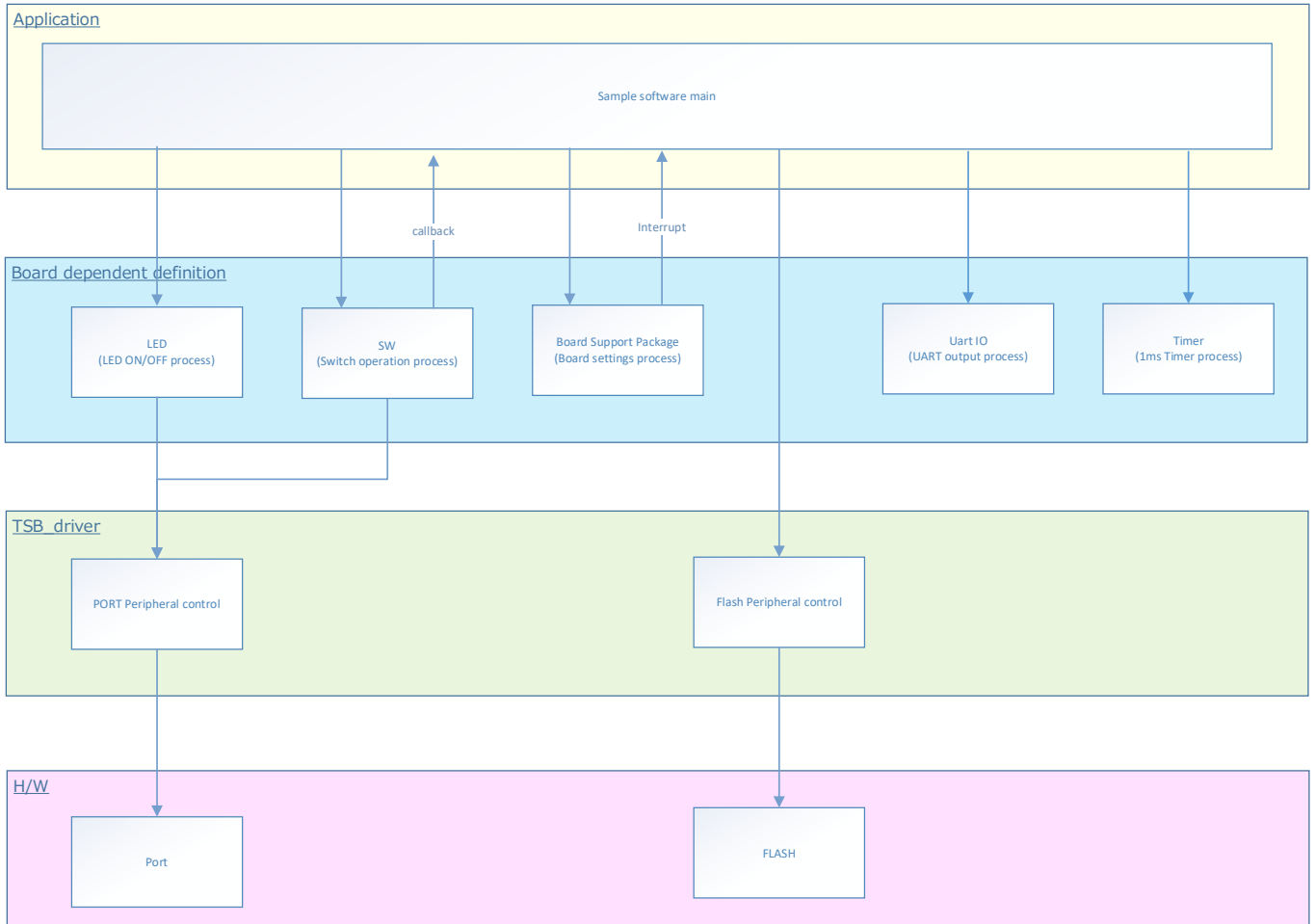

6. Sample Program : FLASH_Code

This is sample software that swaps CODE_area_A and CODE_area_B each time BSP_PSW_1 is pressed and executes CODE_area_A.

6.1. Outlines of Operation

Executes the processing of CODE_area_A.

When BSP_PSW_1 is pressed, BSP_LED_1 is turn on, BSP_LED_2 is turn off, BSP_LED_3 is turn on, and BSP_LED_4 is turn off.

Also, save the CODE_area_A to RAM_A and the CODE_area_B to RAM_B.

Erases the data in the CODE_area.

After that, the contents of RAM_B are written in CODE_area_A, and the contents of RAM_A are written in CODE_area_B.

6.2. Function to Use

The functions to use are as follows.

For the Port assignment of each channel, refer to the MCU user guide.
