

6. Sample Program:FLASH_UserInformation

This is sample software that accesses (Write / Erase) User Information A each time BSP PSW 1 is pressed.

6.1. Outlines of Operation

When BSP_PSW_1 is pressed, the data of Backup Size will be saved to RAM_A from the beginning Of User Information A.

Then, User Information A is erased and string A is written to the first address of User Information A.

6.2. Function to Use

The functions to use are as follows:

For the Port assignment of each BSP channel, refer to the MCU user guide.

T32A	BSP_T32A_TIMER_1	Interval timer
UART	BSP_UART _1	For terminal emulator communication (Outputs log)




7.2. variable_initalize




