

## 6. Sample Program:SIWDT

This sample software uses SIWDT function to turn off the blinking LED at startup when a watchdog timer interrupt is detected.

#### 6.1. Outlines of Operation

At startup, BSP\_LED\_1~4 will blink repeatedly at 200ms intervals.

When WDT detect period has elapsed, the watchdog timer interrupt is generated and LED is turned off.

WDT counting is cleared when the compile switch DEMO\_WDT\_CLEAR is Enable.
