




Fig. 6.1 Test Circuit




Fig. 6.2 Timing Chart




Fig. 7.1 Ic - VCE




Fig. 7.3 V_{GE} - Q_g




Fig. 7.5 Eon - Ic




Fig. 7.2 I_C - V_{CE}




Fig. 7.4 Capacitance - VCE




Fig. 7.6 Eoff - Ic






Fig. 7.7 E_{on} - R_{G(on)}




Fig. 7.9 Switching time - I_C




Fig. 7.11 RBSOA (Guaranteed value)




Fig. 7.8 E_{off} - R_{G(off)}





Fig. 7.10 R_{th(j-f)} - t (Guaranteed value)
