




Fig. 7.1 Marking




Fig. 9.1 I_F - V_F (Per Leg)




Fig. 9.3 I_R - V_R (Per Leg)




Fig. 9.5 Q_c - V_R (Per Leg)




Fig. 9.2 I_F - V_F (Per Leg)




Fig. 9.4 C_t - V_R (Per Leg)








Fig. 9.6 $r_{th(j-c)}$ - t_w (Per Leg) (Guaranteed Maximum)








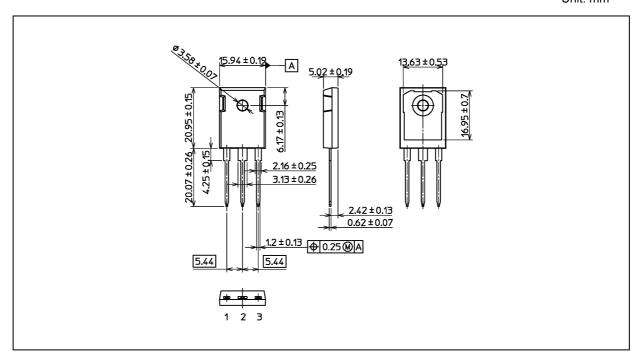
Fig. 9.8 P_D - T_c (Per Leg) (Guaranteed Maximum)
