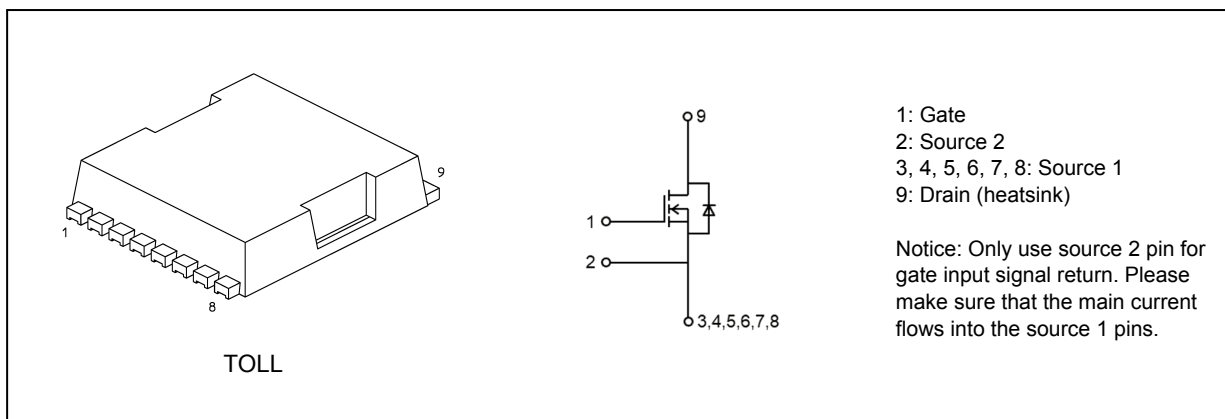

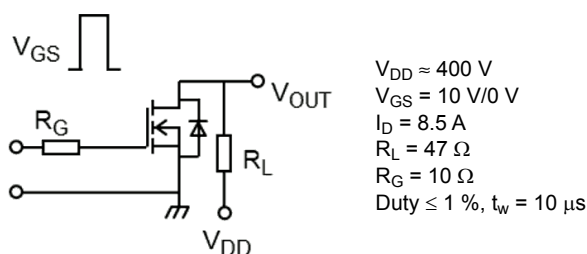


Fig. 6.2.1 Switching Time Test Circuit

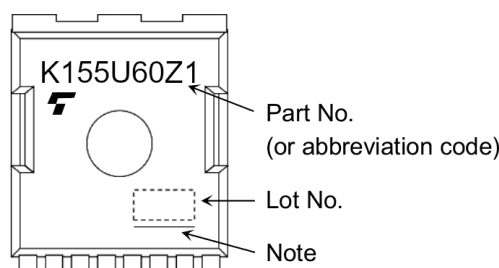

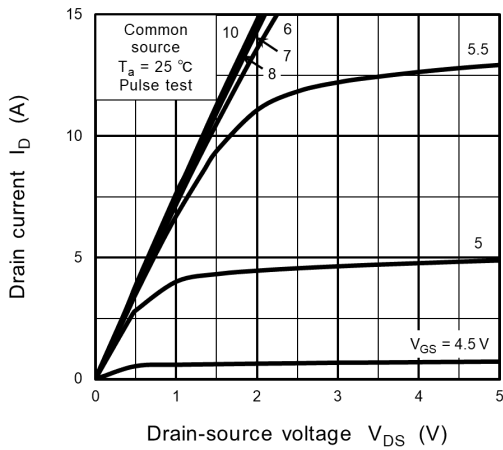


Fig. 8.1  $I_D - V_{DS}$

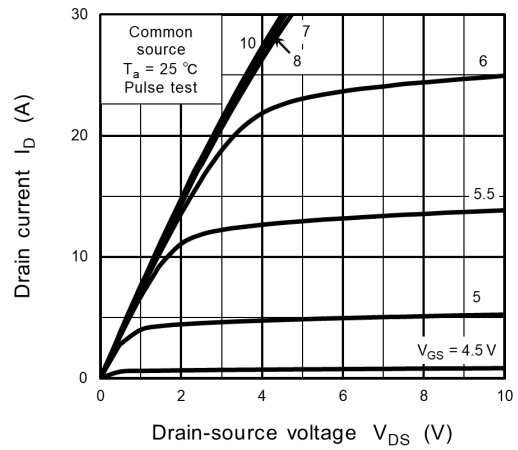


Fig. 8.2  $I_D - V_{DS}$

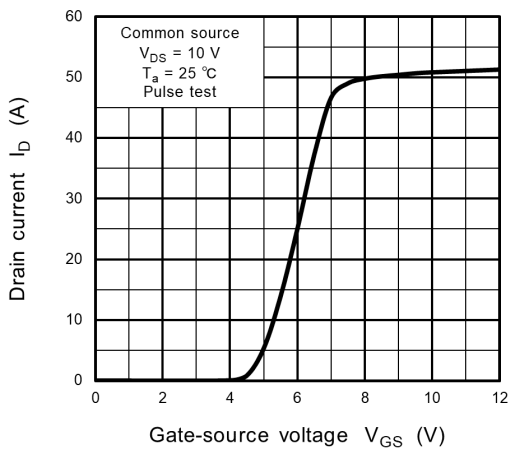


Fig. 8.3  $I_D - V_{GS}$

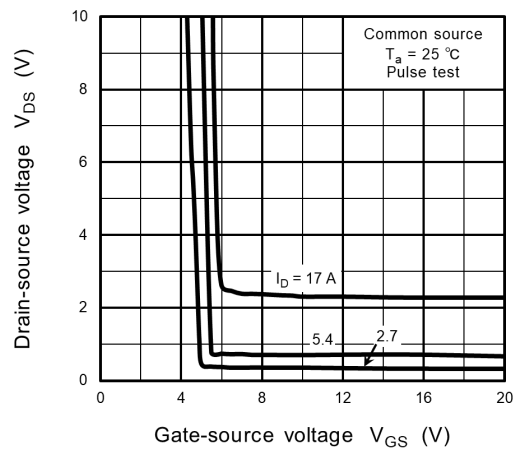


Fig. 8.4  $V_{DS} - V_{GS}$

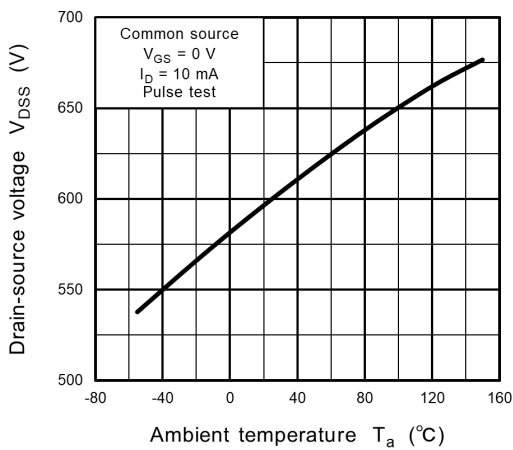


Fig. 8.5  $V_{DSS} - T_a$

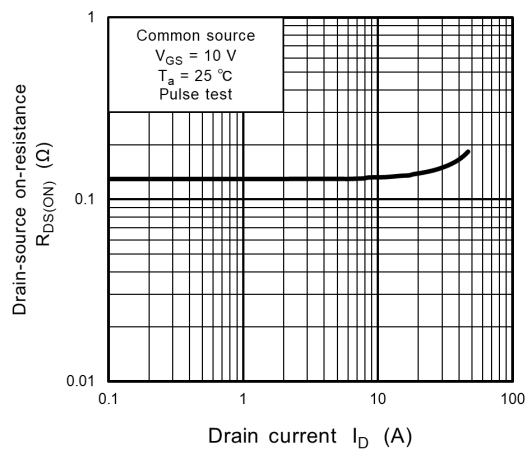
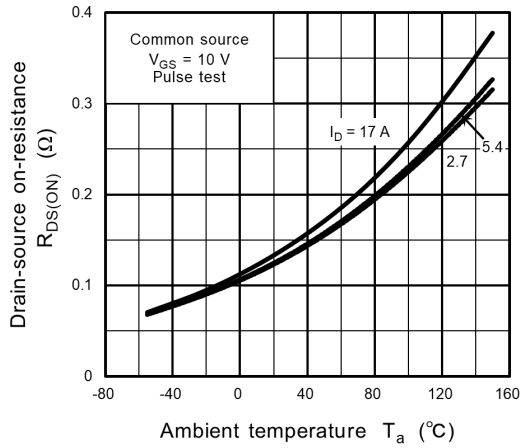
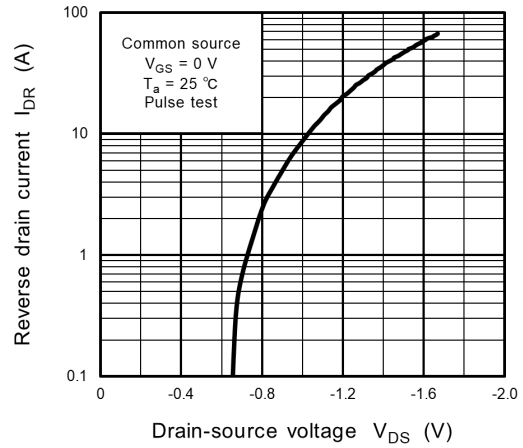


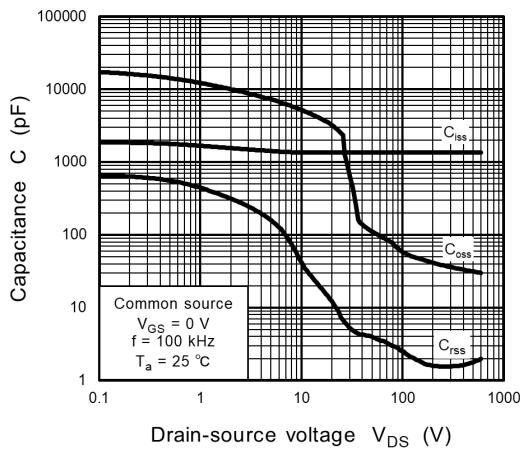
Fig. 8.6  $R_{DS(ON)} - I_D$



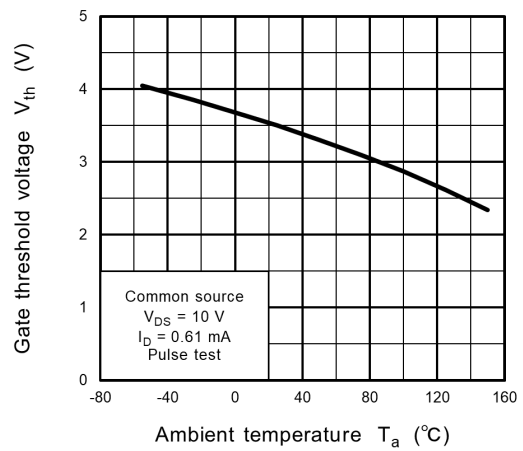
**Fig. 8.7**  $R_{DS(ON)} - T_a$



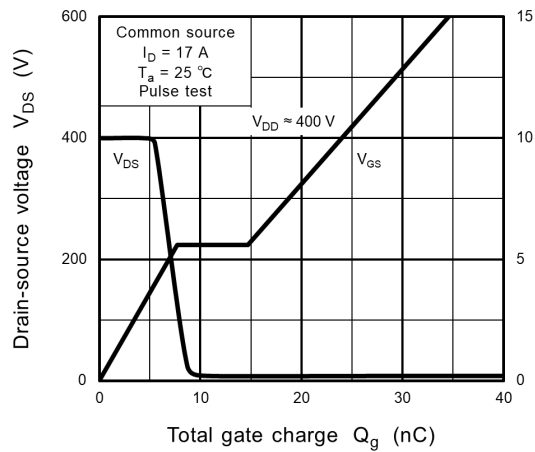
**Fig. 8.8**  $I_{DR} - V_{DS}$



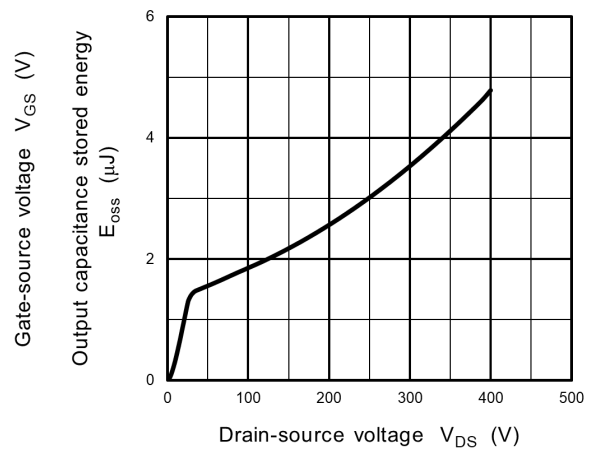
**Fig. 8.9**  $C - V_{DS}$



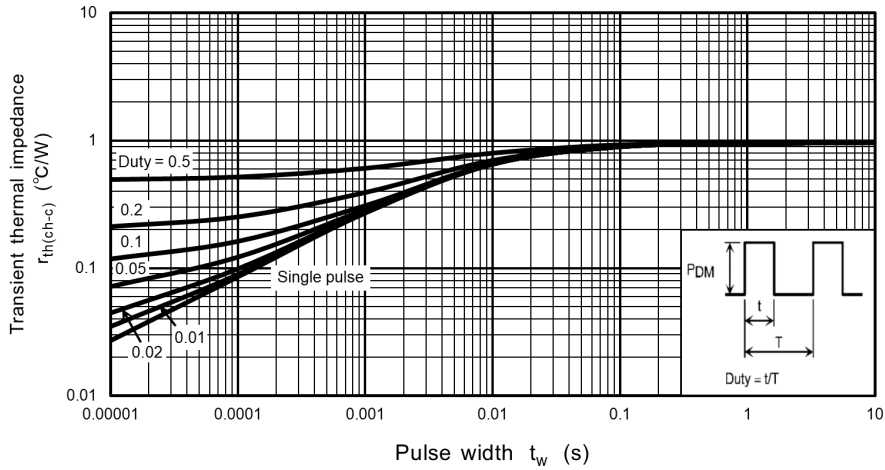
**Fig. 8.10**  $V_{th} - T_a$



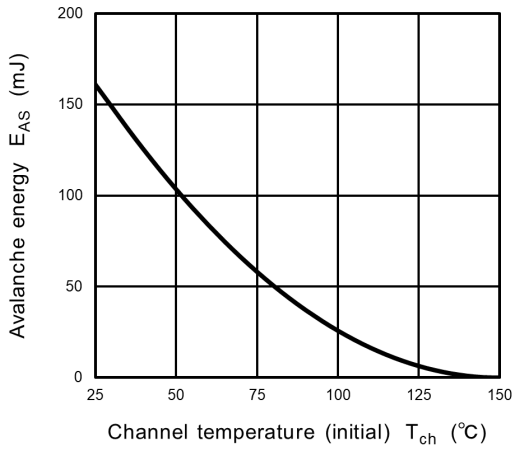
**Fig. 8.11** Dynamic Input/Output Characteristics



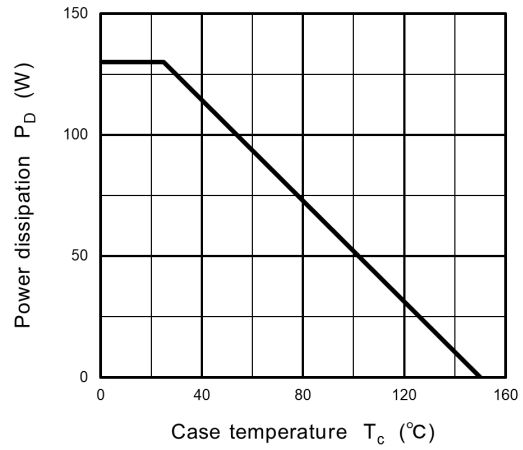
**Fig. 8.12**  $E_{oss} - V_{DS}$



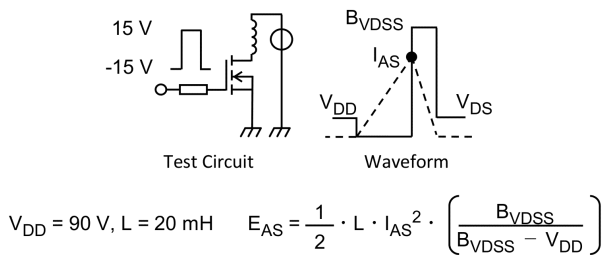
**Fig. 8.13  $r_{th} - t_w$**   
(Guaranteed Maximum)



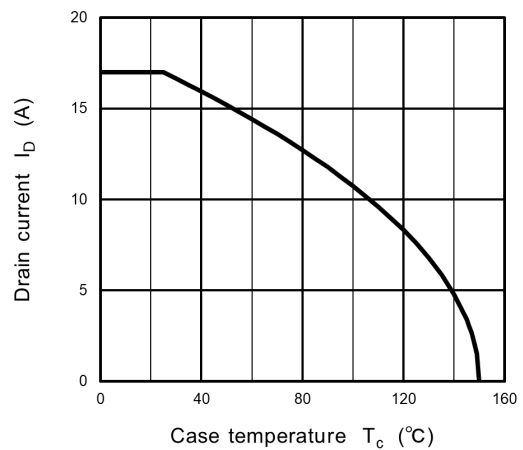
**Fig. 8.14  $E_{AS} - T_{ch}$**   
(Guaranteed Maximum)



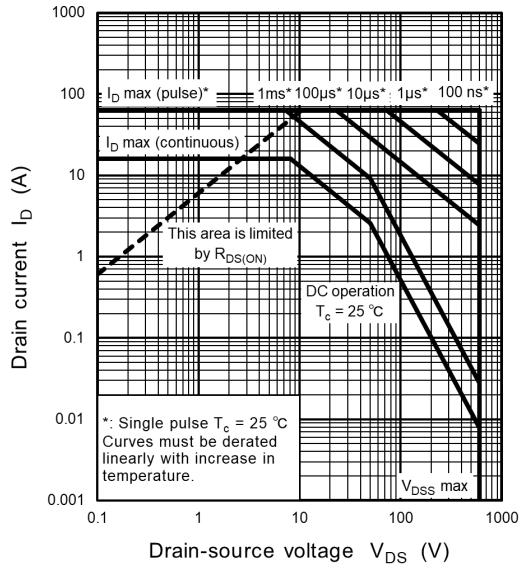
**Fig. 8.15  $P_D - T_c$**

(Guaranteed Maximum)

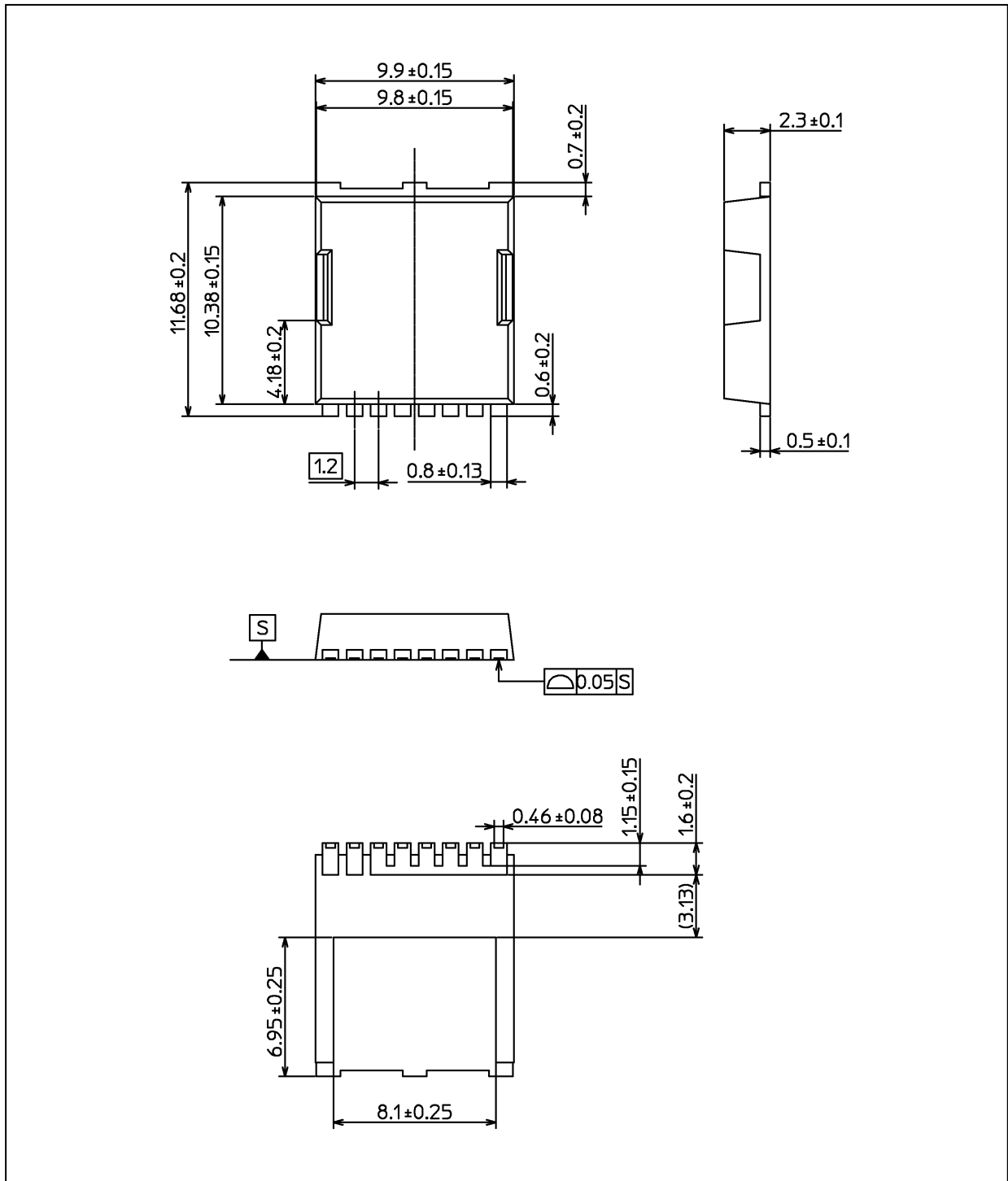


**Fig. 8.18 Safe Operating Area (Guaranteed Maximum)**
