

### 6. Sample Program:DNF

This is sample software that displays the external signal interrupt detection by pressing Push-Switch by switching the LED lighting.

#### 6.1. Outlines of Operation

BSP\_LED\_1 is controlled when BSP\_PSW\_5 is pressed. If you press BSP\_PSW\_5 when BSP\_LED\_1 is off, BSP\_LED\_1 will turn on. If BSP\_PSW\_5 is pressed while BSP\_LED\_1 is on, BSP\_LED\_1 will turn off. Detects external signal interrupts caused by pressing Push-Switch via DNF.

#### 6.2. Function to Use

The functions to use are as follows:

For the Port assignment of each BSP channel, refer to the MCU user guide.

IP	Channel	Objective
PORT(Push-Switch)	(Note1) BSP_ PSW_5	(Note1) For event triggers
PORT(LED)	BSP_LED_1	For operation check
T32A	BSP_T32A_TIMER_1	For Interval timer
Note1: For SPK M4KN (SPK M4KN10) SPK M4K4P, and SPK M471, upp PSP, SSM, 1 instead		

Note1: For SBK-M4KN (SBK-M4KN10), SBK-M4K4B, and SBK-M471, use BSP\_SSW\_1 instead.
