

Note: The MOSFETs in this device are sensitive to electrostatic discharge. When handling this device, the worktables, operators, soldering irons and other objects should be protected against anti-static discharge.

Note: The channel-to-ambient thermal resistance, R_{th(ch-a)}, and the drain power dissipation, P_D, vary according to the board material, board area, board thickness and pad area. When using this device, be sure to take heat dissipation fully into account.

- Note 1: If a reverse bias is applied between gate and source, this device enters $V_{(BR)DSX}$ mode. Note that the drain-source breakdown voltage is lowered in this mode.
- Note 2: Let V_{th} be the voltage applied between gate and source that causes the drain current (I_D) to below (0.1 mA for this device). Then, for normal switching operation, V_{GS(ON)} must be higher than V_{th}, and V_{GS(OFF)} must be lower than V_{th}. This relationship can be expressed as: V_{GS(OFF)} < V_{th} < V_{GS(ON)}.

 Take this into consideration when using the device.




Fig. 6.2.1 Switching Time Test Circuit




Fig. 6.2.2 Input Waveform/Output Waveform



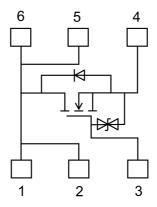




Fig. 9.1 I_D - V_{DS}




Fig. 9.3 R_{DS(ON)} - V_{GS}




Fig. 9.5 R_{DS(ON)} - T_a




Fig. 9.2 I_D - V_{GS}




Fig. 9.4 R_{DS(ON)} - I_D




Fig. 9.6 V_{th} - T_a




Fig. 9.7 C - V_{DS}




Fig. 9.9 P_D - T_a




Fig. 9.8 Dynamic Input Characteristics




Fig. 9.10 Safe Operating Area





Fig. 9.11 r_{th} - t_w
