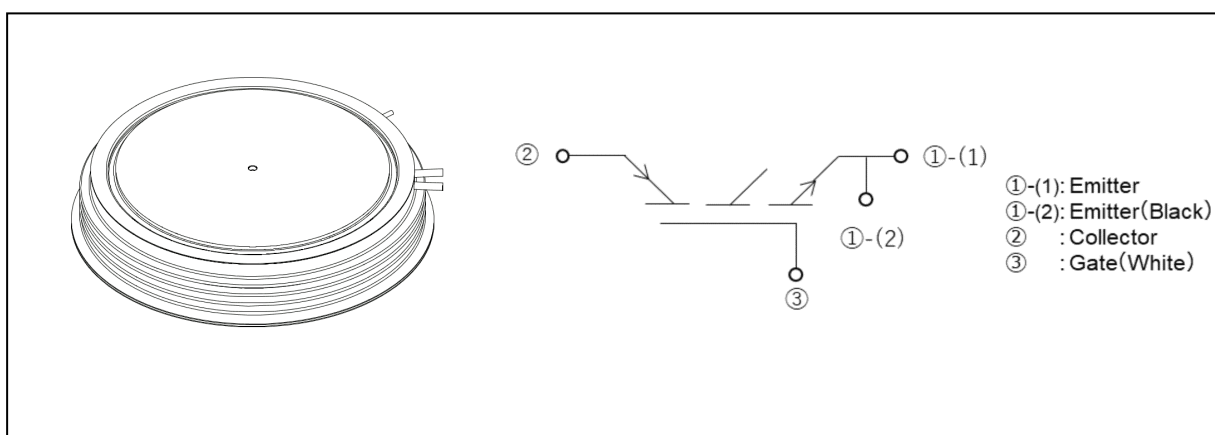

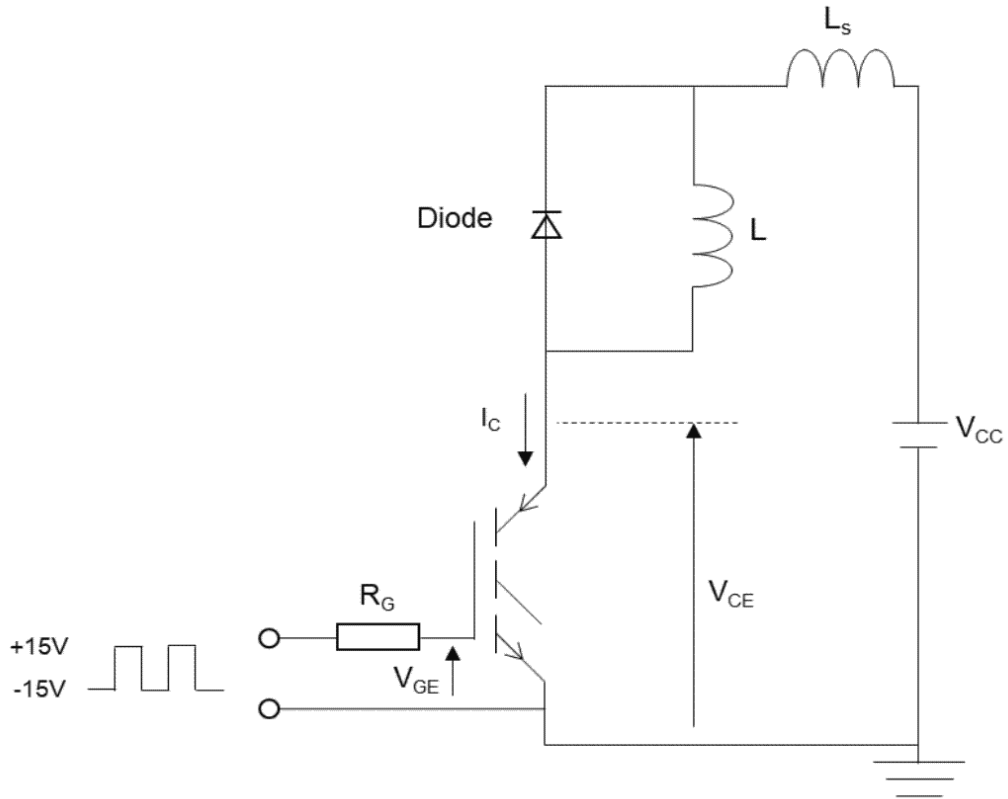


Fig. 6.1 Test Circuit

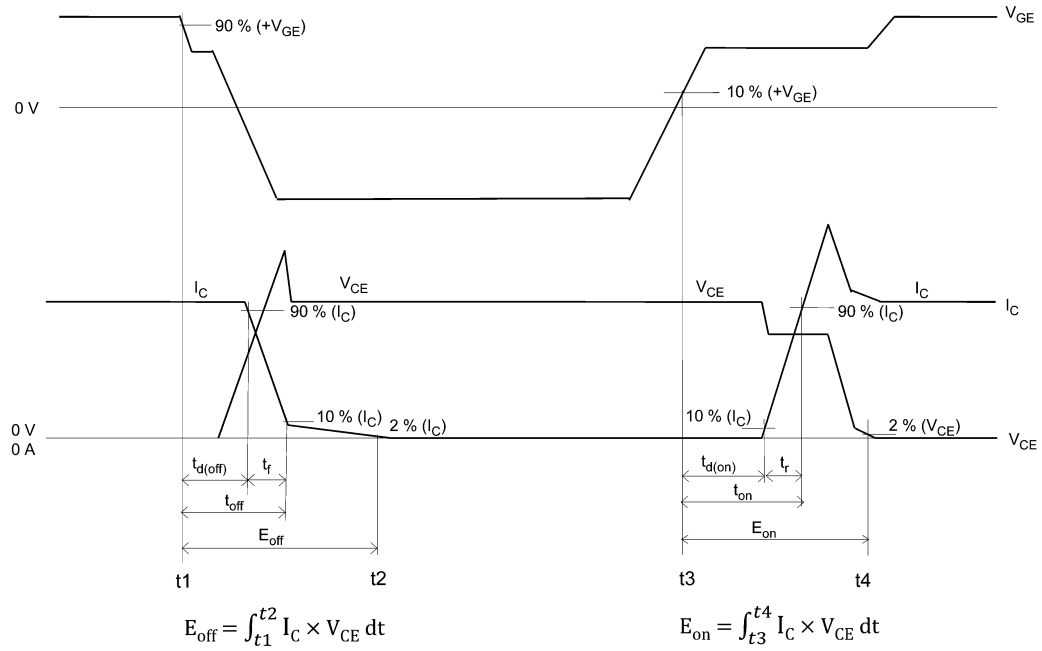


Fig. 6.2 Timing Chart

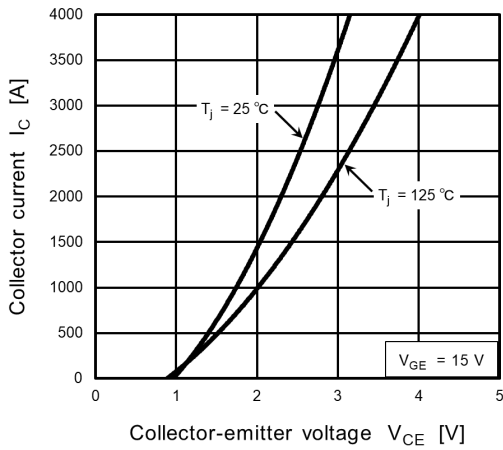


Fig. 7.1  $I_C - V_{CE}$

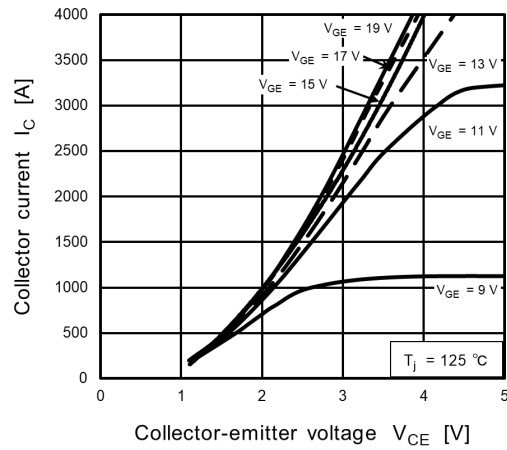


Fig. 7.2  $I_C - V_{CE}$

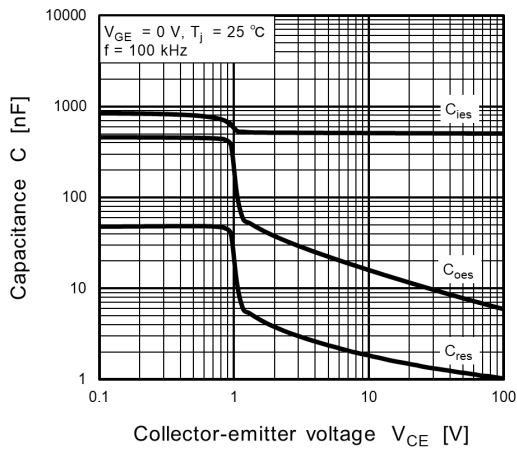


Fig. 7.3 Capacitance -  $V_{CE}$

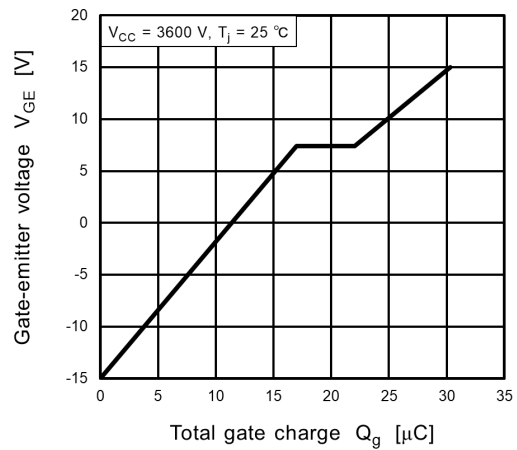


Fig. 7.4  $V_{GE} - Q_g$

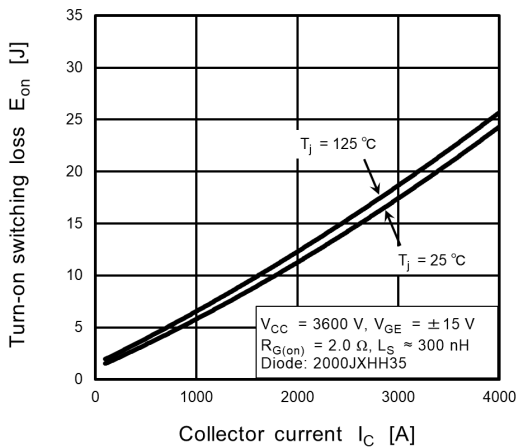


Fig. 7.5  $E_{on} - I_C$

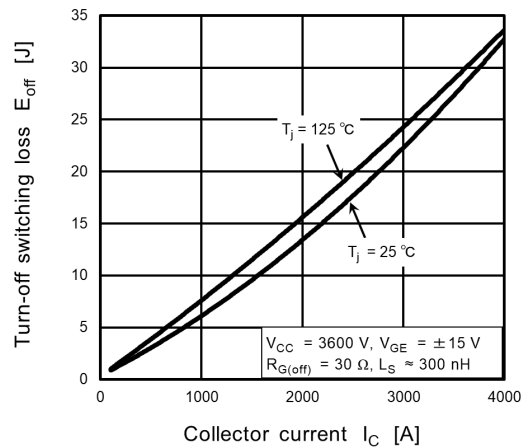
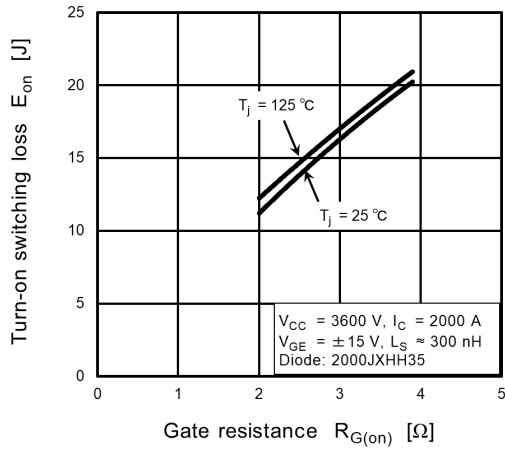
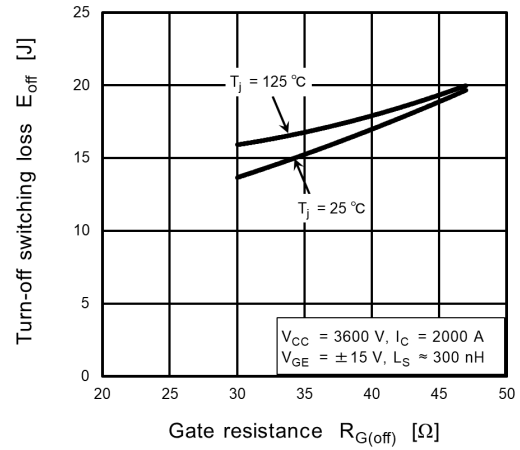


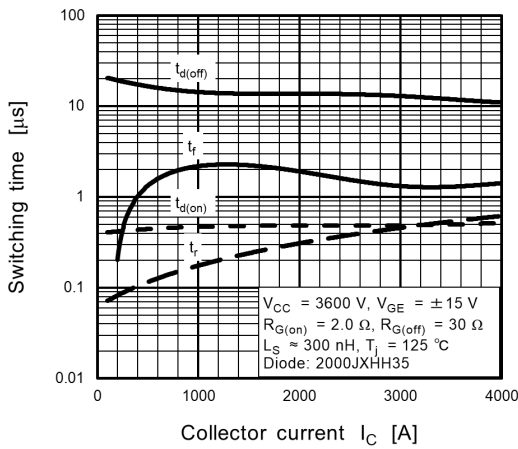
Fig. 7.6  $E_{off} - I_C$



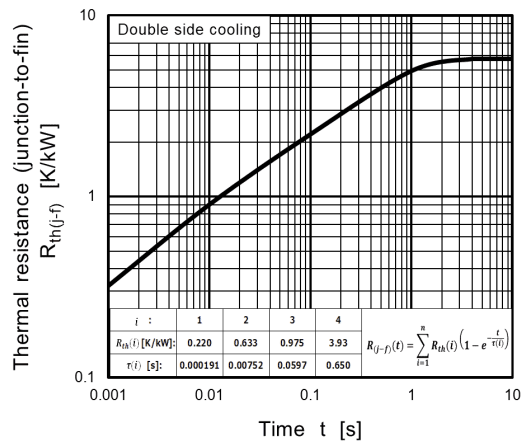
**Fig. 7.7 E<sub>on</sub> - R<sub>G(on)</sub>**



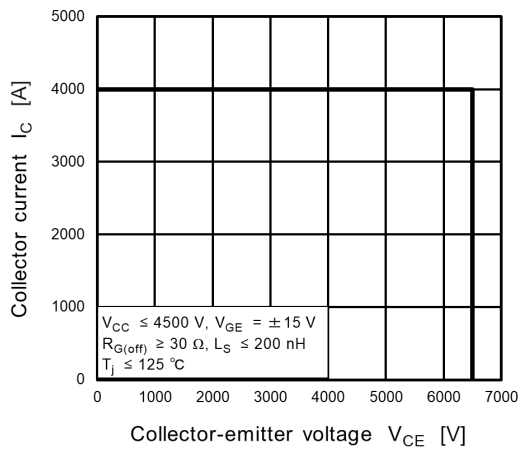
**Fig. 7.8 E<sub>off</sub> - R<sub>G(off)</sub>**

**Fig. 7.10 R<sub>th(j-f)</sub> - t (Guaranteed value)**

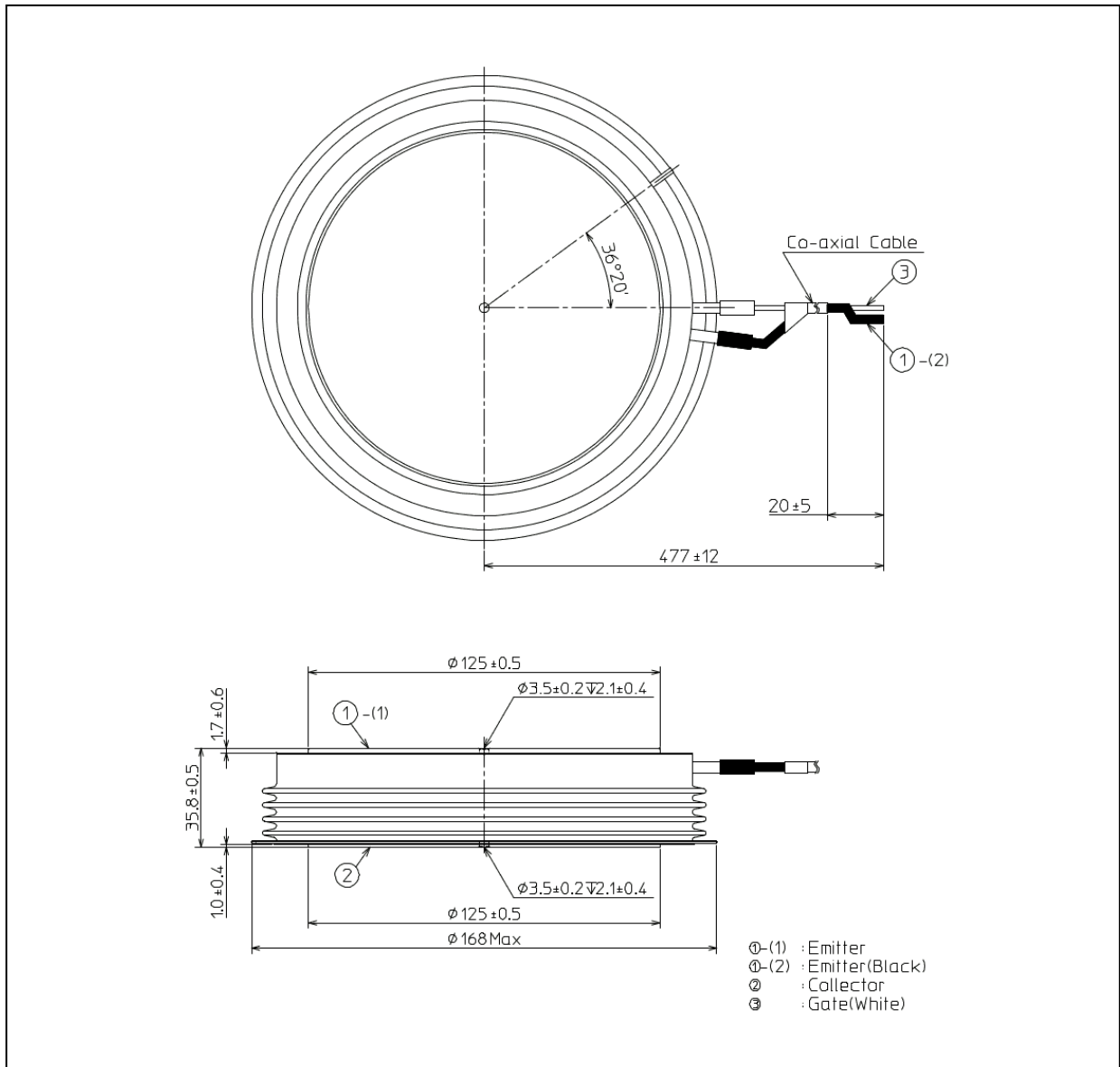


**Fig. 7.11 RBSOA (Guaranteed value)**
