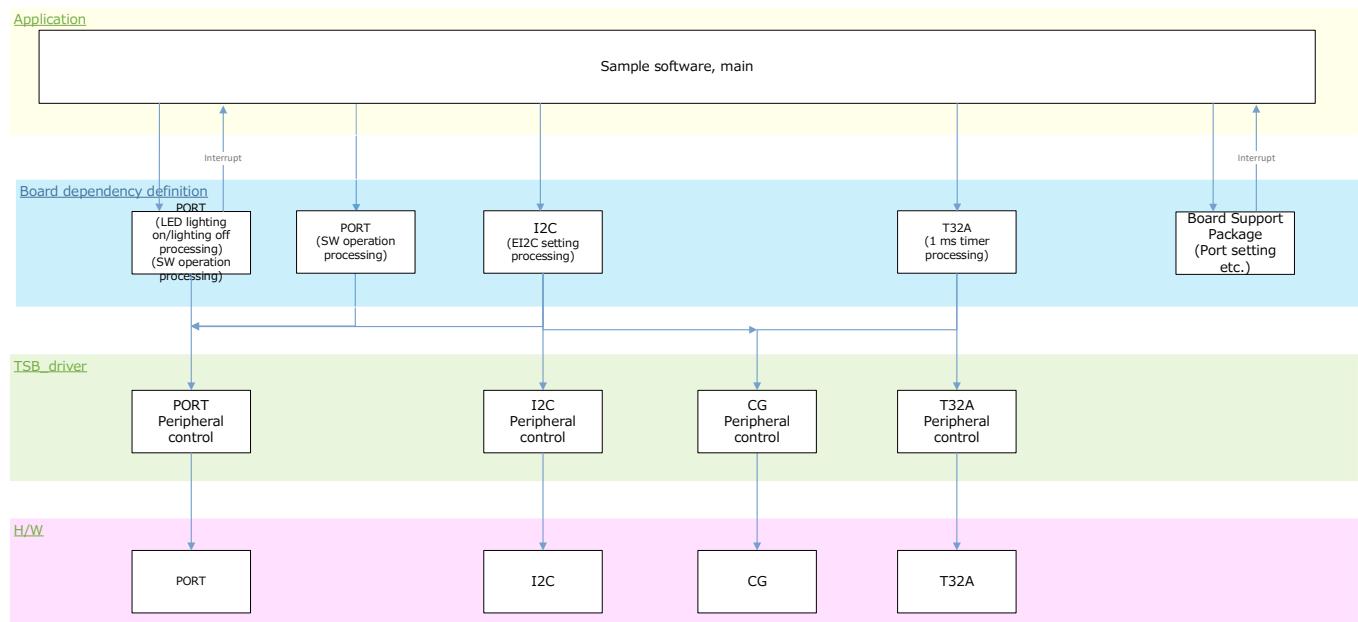

## 6. Sample Program: I2C\_TARGET\_RECEIVE

This sample software that switches the LED on and off each time data reception is completed using the Target reception processing function of the I2C communication function.

### 6.1. Outlines of Operation

Turn off BSP\_LED\_2 and BSP\_LED\_3.

When BSP\_PSW\_1 is pressed, BSP\_LED\_3 is turned off and data for the data reception size is received.

After receiving, the lighting state (turn on / turn off) of BSP\_LED\_2 is switched.

When an error occurs, BSP\_LED\_3 is turned on.

### 6.2. Function to Use

The functions to use are as follows:

For the Port assignment of each BSP channel, refer to the MCU user guide.
