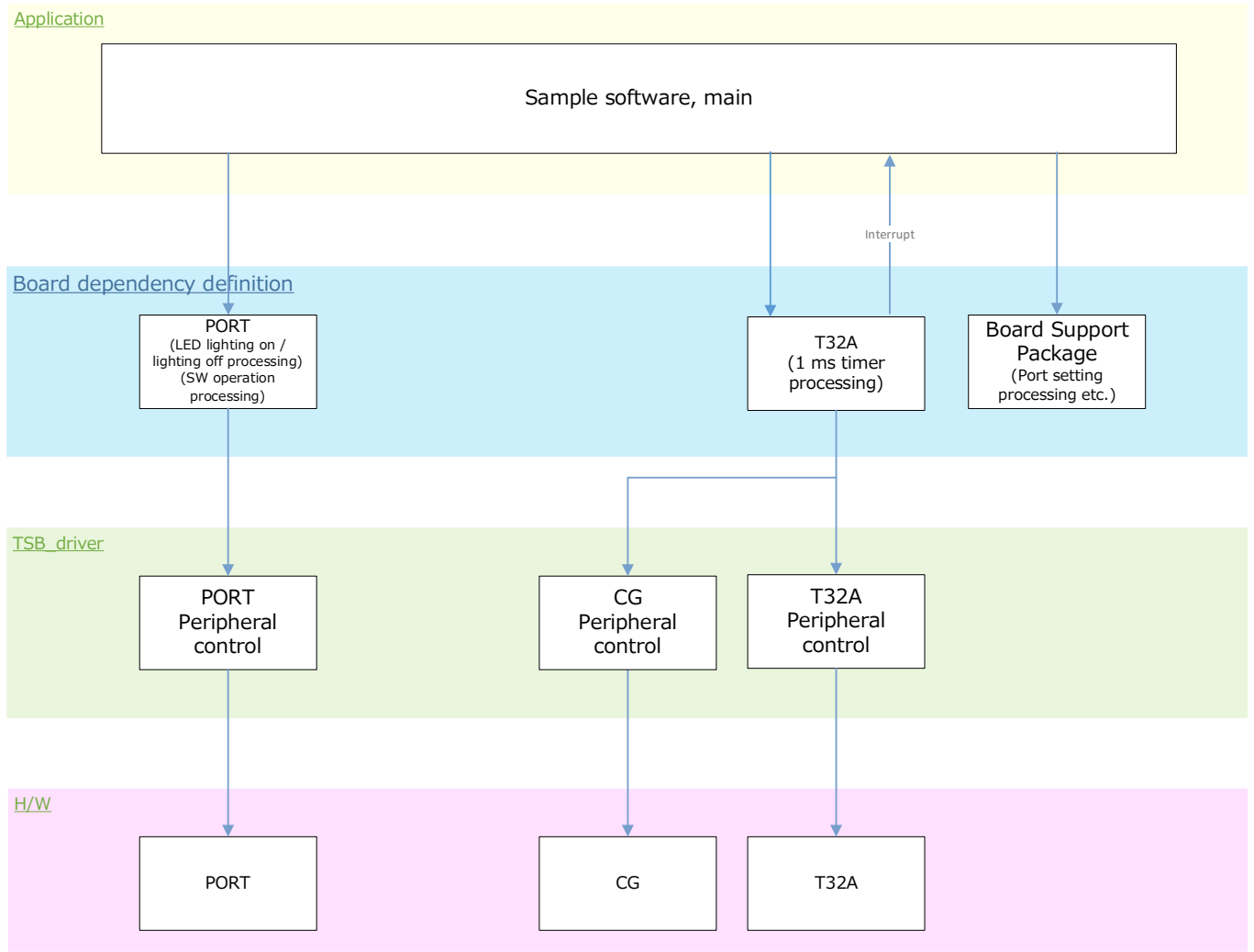

6. Sample Program: T32A_IntervalTimer

This sample software is software that repeats turn on and off the LED every second.

6.1. Outlines of Operation

Each time Timer A elapses, BSP_LED_1, BSP_LED_2, BSP_LED_3, and BSP_LED_4 are turn ON / OFF.

When BSP_PSW_1 is pressed, the LED turn off.

When BSP_PSW_2 is pressed, the LED blinks in 500ms cycles.

The functions to use are as follows:

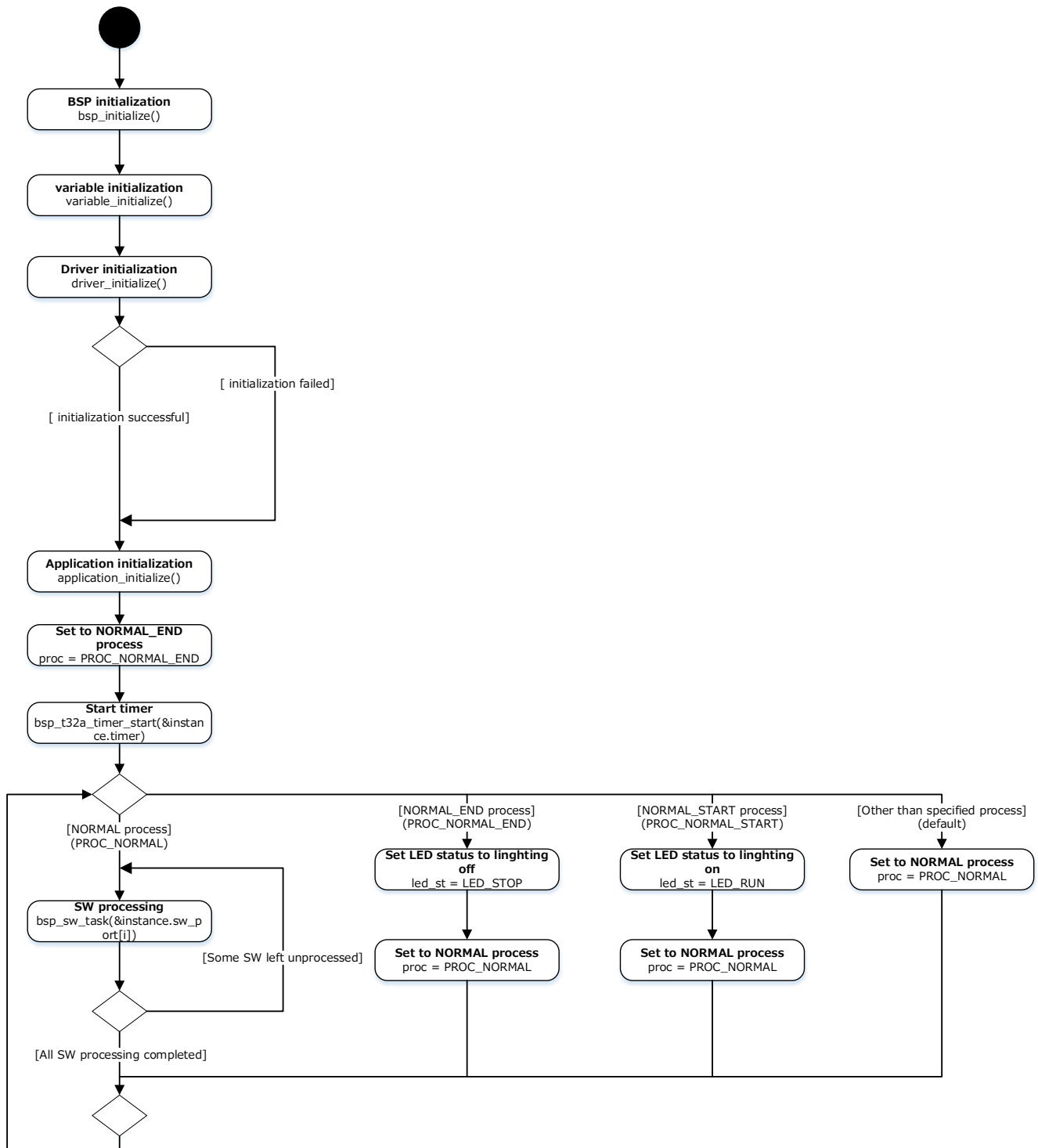

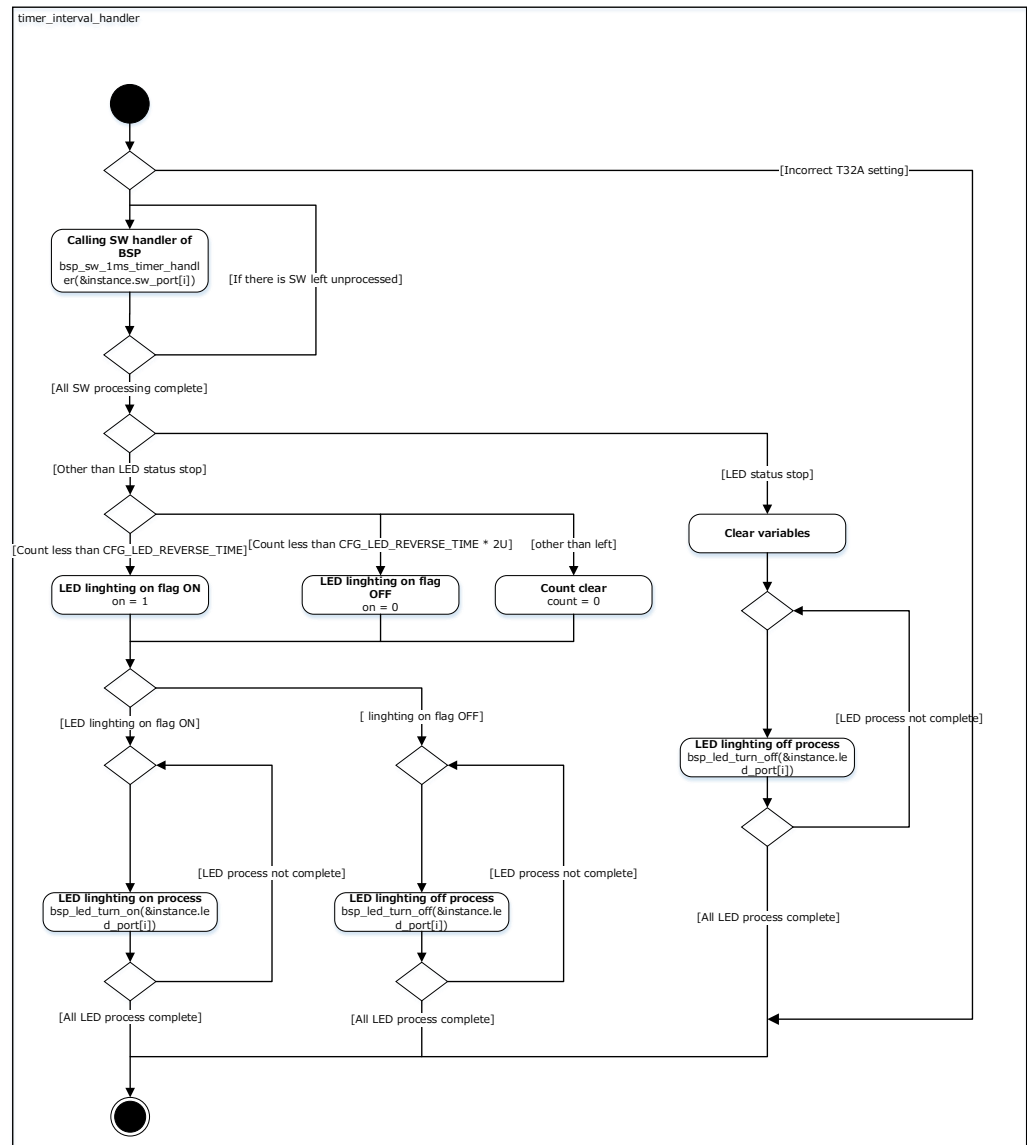
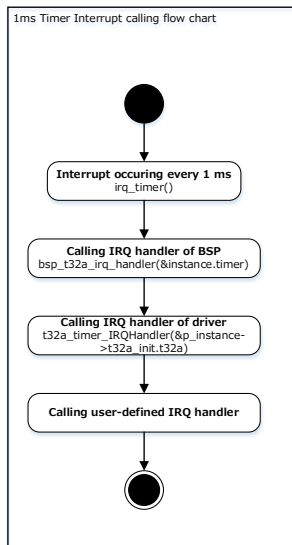
