






Fig. 8.1 Marking RN1312




Fig. 8.2 Marking RN1313




Fig. 9.5 RN1312 h_{FE}-I_C




Fig. 9.7 RN1312 V_{CE(sat)}-I_C

Fig. 9.8 RN1313 V_{CE(sat)}-I_C





Fig. 9.9 RN1312,RN1313 P_C-T_a
