




Fig. 9.3 Marking RN2116




Fig. 9.5 Marking RN2118




Fig. 9.2 Marking RN2115





Fig. 9.4 Marking RN2117


Fig. 10.2 RN2115 I_C-V_{I(ON)}




Fig. 10.3 RN2116 I_C-V_{I(ON)}





Fig. 10.5 RN2118 I_C-V_{I(ON)}








Fig. 10.8 RN2116 I_C-V_{I(OFF)}




Fig. 10.10 RN2118 I_C-V_{I(OFF)}




Fig. 10.7 RN2115 I_C-V_{I(OFF)}





Fig. 10.9 RN2117 I_C-V_{I(OFF)}




Fig. 10.15 RN2118 h_{FE}-I_C




Fig. 10.20 RN2118 V_{CE(sat)}-I_C


