





Fig. 5.1 Reverse recovery time  $(t_{rr})$  Test circuit




Fig. 7.1 I<sub>F</sub> - V<sub>F</sub>




Fig. 7.2  $I_R - V_R$ 




Fig. 7.3 C<sub>t</sub> - V<sub>R</sub>





Fig. 7.4 t<sub>rr</sub> - I<sub>F</sub>
