Please be careful of the following:

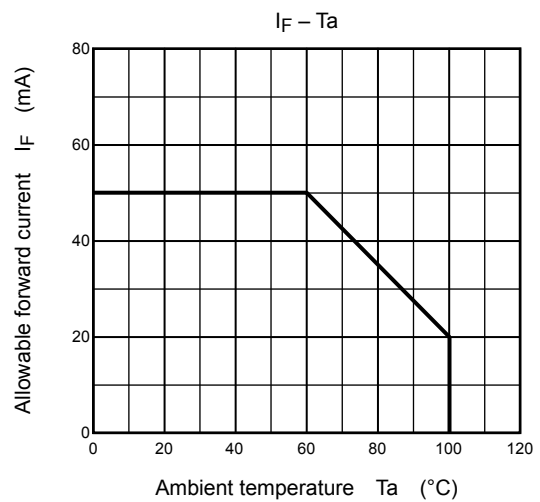
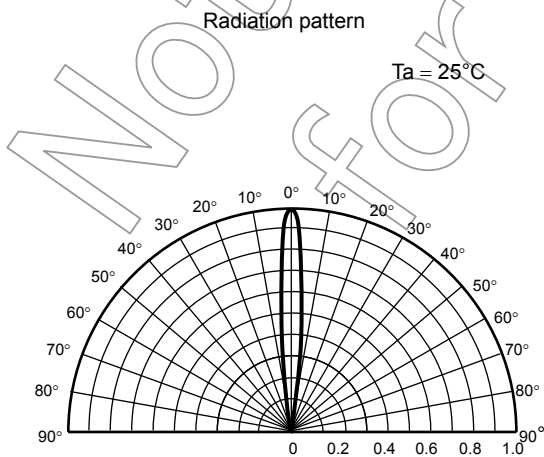
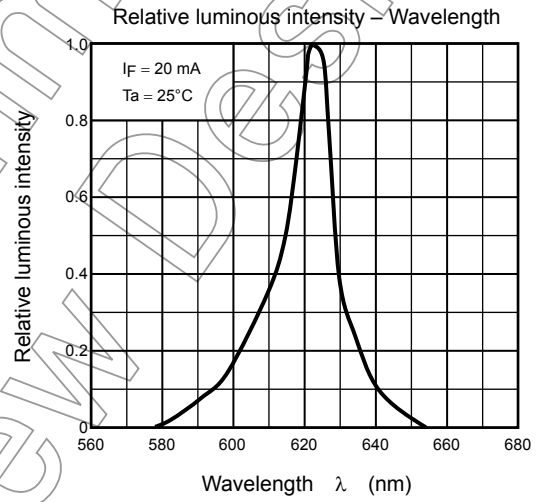
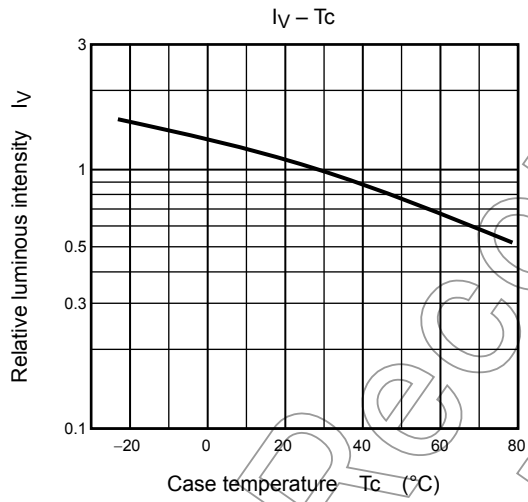
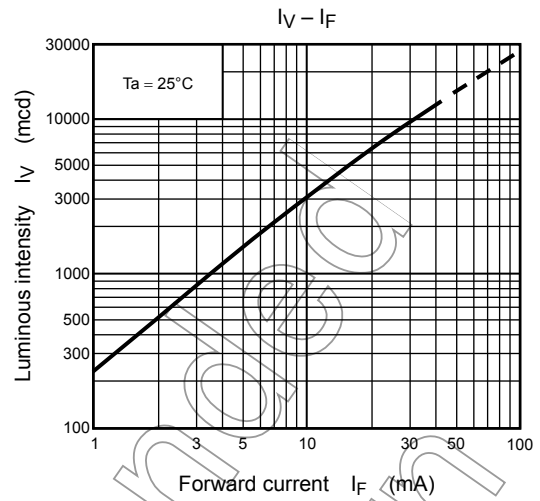
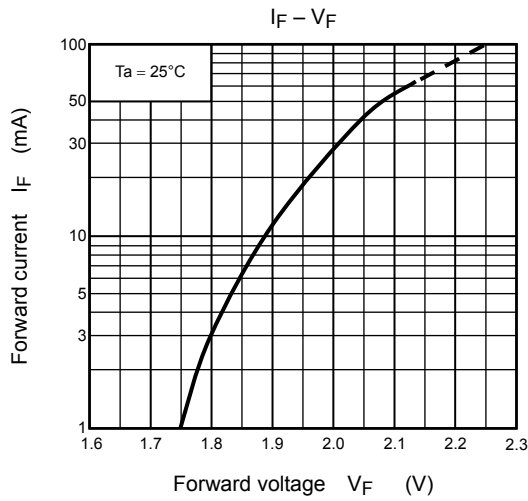
- Soldering temperature: 260°C max, soldering time: 3 s max
