

Then, for normal switching operation, $V_{GS(ON)}$ must be higher than V_{th} , and $V_{GS(OFF)}$ must be lower than V_{th} . 









Fig. 8.12 Dynamic Input Characteristics







Fig. 8.14 Safe Operating Area




