#### 1. Functional Description

Hex Schmitt Inverter

#### 2. General

 $The \, TC74AC14P \, is an advanced \, high \, speed \, CMOS \, SCHMITT \, INVERTER \, fabricated \, with \, silicon \, gate \, and \, double-layer \, metal \, wiring \, C^2MOS \, technology.$ 


It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low pwer dissipation.

Pin configuration and function are the same as the TC74AC04P but the inputs have hysteresis and with its schmitt trigger function, the TC74AC14P can be used as a line receivers which will receive slow input signals. All inputs are equipped with protection circuits against static discharge or transient excess voltage.



- (1) High speed:  $t_{pd}$  = 5.3 ns (typ.) at  $V_{CC}$  = 5.0 V
- (2) Low power dissipation:  $I_{CC}$  = 4.0  $\mu$ A (max) at  $T_a$  = 25 °C
- (3) Output current:  $|I_{OH}|/I_{OL} = 24 \text{ mA} (\text{min}) (V_{CC} = 4.5 \text{ V})$
- (4) Balanced propagation delays:  $t_{PLH} \approx t_{PHL}$
- (5) Wide operating voltage range:  $V_{CC(opr)} = 2.0 \text{ V to } 5.5 \text{ V}$
- (6) Pin and function compatible with 74F14






