




Fig. 4.1 Definitions of Electrical Characteristics





Fig. 5.1 Marking







Fig. 7.1 I - V





8. Clamp Voltage V_C - Peak Pulse Current (I_{PP}) (Note)








Fig. 8.2 Based on IEC61000-4-5 8/20 μs pulse. (Ed.2)

10. ESD Clamp Waveform (Note)





Fig. 10.3 IEC61000-4-2 (Contact)
